- 1. Two bid systems should be followed for submitting the offer in the prescribed form i.e. Schedule 'A' duly filled in which the rates written in words & figures & signed should be sent by registered post or in person to the Office of Executive Engineer, Pimpri–Chinchwad Division, Pune on or before 26.11.2025 up to 16:00 Hrs

- 3. The offer shall be valid for acceptance for a period of 90 days from the date of submission of quotation.
- 4. All the documents of this enquiry, Schedule 'A' & other accompanying documents shall bear the authorized signature of the Bidder, failing which the offer will be liable for rejection.

Two bid systems should be followed for submitting the offer.

### A. Technical bid (Two bid system)

This should contain following documents/certificates as a proof of qualifying pre-requisites, brochures, attested certificates etc.

#### B. Commercial bid (Two bid system):-

- 1. Techno-commercial bid will be opened for all received bids. After verification of all documents /certificates submitted in technical bid for prequalification as mentioned above, if it is found that, the enquiry fulfills the desired prerequisites; the price bid (envelope) will be opened. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Enquiry with incomplete details or not submitted in prescribed enquiry form etc. are liable for rejection.
- 2. This office reserves all rights to reject any or all quotations/bid without assigning any reasons thereof.
- 3. The technical documents should be submitted in separate envelop as the technical bid & commercial/price bid should be submitted in separate envelope separately. In case both Technical & Commercial bid are submitted in one envelope wrongly, the offer will be rejected.
- 4. If validity of any license/certificate expires during order period, contractor will have to renew the same & submit the copy to this office. Payment will be affected for valid period only.

#### **General Terms and Conditions**

- 1. <u>AGREEMENT</u>: Bidder will have to execute the agreement bond with the Executive Engineer, EHV O&M Division Pimpri Chinchwad, Pune on stamp paper of 500/- within 15 days from date of issue of LOI. The cost of stamp paper will be borne by the contractor. After submission of agreement, the contractor will be called for scheduling the date of signing & execution of agreement in the office of Executive Engineer, EHV O&M Division, Pimpri Chinchwad, Pune. Until the agreement is executed, the MSETCL will not be liable to pay nor shall the bidder be entitled to claim amount due or payable under the contract. The necessary stamp duty for the agreement shall be borne by the bidder.
- 2. <u>SECURITY DEPOSITE:</u> Bidder will have to pay Security Deposit of 5% of the work order value within 7 days from the date of issue of LOI in the form of FDR/B.G. of any Nationalized/ scheduled Bank in the favor of "MSETCL" at the office of The Executive Engineer, EHV O&M Dn Pimpri Chinchwad Pune, valid for one year or online payment NEFT/RTGS. If you fail to do so, the SD will be recovered from your first bill with interest as per SBI PLR 18%. The Security deposit will be refunded only after satisfactory completion of the guarantee period. Also, you will have to apply for refund of SD within 6 months after completion of guarantee period. If you fail to apply within stipulated period, the action as per CO's rules will be taken.

Please note that, the % of SD Clause of the work order may vary as per rules & guidelines issued by MSETCL / Govt from time to time. Same will be binding on you.

3. **SCOPE OF WORK**: The scope of work includes for supply of Self-support Aluminium ladder (ghoda shidi) with extension having size of 20ft x 35ft for Substations under EHV O&M Division, Pimpri Chinchwad, Pune as per mentioned in Schedule A.

The detailed specifications of Self-support Aluminium ladder (ghoda shidi) with extension having size of 20ft x 35ft is as follows

- It should have 67mm strong side rails made up of high tensile aluminium alloy.
- It should have corrugated steps ensures anti slip surface & firm grip.
- It should have convenient extension & retraction of fly section.
- It should have aluminium slip resistant platform of 8" x 11" lifted at 3 ft from the top.
- It should have aluminum casted catcher which ensure firm grip. Lockable at every rug.
- It should prevent sway of the back section of the ladder while folded.
- Maximum work height should be 38 ft.

The material not confirming to the above specifications shall be rejected

- 4. **OPERATING OFFICER: -** The Additional Executive Engineer, Substation Maintenance Subdivision. Pimpri Chinchwad is hereby appointed as Engineer In Charge /Operating Officer for this work. The supply of material is to be carried out in presence of operating officer or his representative and up to his entire satisfaction.
- 5. **DELIVERY OF MATERIAL:** Material shall be delivered within 02 months from the date of receipt of order at S/Stn. as per schedule B under EHV O&M Pimpri Chinchwad Division, Pune. The supply of material is to be carried out in presence of operating officer or his representative and up to his entire satisfaction
- 6. **PERIOD OF CONTRACT:** The contract for the period of **12 Months** will be placed with the agency whose rates and offers are found suitable. The undersigned however reserves the right to place the order for any shorter period and to terminate the order at any time if the services are not found satisfactory.

#### 7. SUPPLY OF MATERIAL:

Required material shall be supply immediately after the receiving of the order and as per the call from the Additional Executive Engineer, Substation Maintenance Subdivision, Pimpri Chinchwad. The material to be supplied shall be new & as per manufacturer standard make with guarantee of one year and should be inspected by concern substation incharge before receipt of the material.

If the quality of material/spares is not found satisfactory, then said material is liable to be reject.

8. **GUARANTEE PERIOD**: The supplied material shall be guaranteed for period of 12 months from the final acceptance of the material by the Additional Executive Engineer, Substation Maintenance Subdivision, Pimpri Chinchwad. If the material supplied found defective due to bad design or

workmanship that should be replaced by the contractor at free of cost immediately or otherwise same will be deducted from your bill/ S.D. All costs for the replacement of defective parts such as supply, transportation, etc. shall be to the account of the contractor.

- 9. **PENALTY:-** If you fail to supply the material within stipulated time as mentioned above, you will be liable to pay penalty @ 1/2% per week, maximum to 10% of order amount shall be levied on contract value.
- 10. Labour & T&P for the supply will be on your account. Required man power and machinery should be arranged by you
- 11. PACKING/ HANDLING & TRANSPORATTION OF MATERIAL: The contractor should be fully responsible for packing, forwarding & transportation of material by any other authorized mode of transport, clearance of equipment & further transportation of site place to work/ storage yard, etc. in respect of material in contractor's scope.

#### 12. PAYMENT OF TAX INVOICE:

Tax invoice in triplicate along with guarantee certificate and delivery challan shall be submitted to The Additional Executive Engineer, Substation Maintenance Subdivision, Pimpri Chinchwad. Bank Details along with bill for RTGS/ NEFT Paymen,t PAN no., GST no. should be mentioned on Tax invoice/ E-invoice (if applicable).

After receipt of Tax invoice, Scrutinizing & auditing will be done at Division Office and payment will be affected accordingly subject to availability of funds.

- 13. **INCOME TAX/ STATUTORY TAXES**: -: Taxes will be applicable as per prevailing rate. Statutory deduction shall be made as applicable.
- 14. **SUB- LETTING OF CONTRACT:** The contract or any part thereof shall not be assigned, transferred, or sublet.
- **15. FORCE MAJEURE**: Only the following conditions shall be considered for the purpose of this clause.
  - a. Natural Phenomenon such as floods, Draughts, Earthquakes, Epidemics etc
  - b. Acts of any Government, Domestic or Foreign such as war (declared or undeclared) Priorities, Guarantees Embargoes etc.
  - c. The party affected by 'Force Measure' shall within 15 days of the occurrence of such a cause, notify the MSETCL in writing with sufficient documentary proof.
- 16. The insurance of your labor's will have to be done at your cost. If you failed to do so, any compensation or claim arising will be your responsibility.
- 17. **TERMINATION OF CONTRACT:** The undersigned reserves the right to terminate the contract at any time during the contract period by giving appropriate notice of 7 days, if it is found that the contractor is not able to cope up with or discharge duties satisfactory/or not able to execute the work as per the order conditions. The discretion of the contract operating authority shall be final & binding on the contractor.

- 18. **APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:** All other Standard Terms and conditions prescribed by M.S.E.T.C.L., regarding supply and work, which are not stated here, are also applicable to this contract.
- 19. The undersigned reserves the right to alter, modify or cancel the above order at any stage, if found necessary.
- 20. **JURIDICTION:** All disputes or differences arising under out of or in connection with this contract, if concluded, shall be subject to exclusive jurisdiction of PUNE Court only.
