The maximum amount of expenditure per month will be limited to Rs. 50,000.00/- which is inclusive of Hiring Charges, Fuel, GST @ 5% and all other taxes & charges.

- 1) **DUE DATE:** - The quotations complete in all respects, duly sealed & super scribed should be submitted to this office **from 18.11.2025 to 25.11.2025 up to 13:00 Hrs positively.**
- 2) **QUOTED RATES:** - Taxes & Charges shall be mentioned clearly. If not mentioned it will be considered inclusive of all taxes & charges.
- 3) **SECURITY DEPOSIT:** - The successful bidder will have to pay 5% of total work order value towards S.D. at EHV (O&M) Division Office Babhaleshwar.
- 4) **VALIDITY OF OFFER:** - The offer should be valid for our acceptance for a period of 1 year from the Due date of same.
- 5) The rates should quote on per day basis.

- 6) No extra charges will be paid for vehicle driver, repairs, oil & all other expenses including accidental damages if any.
- 7) The vehicle should be in good condition & not more than 05 year old (i.e. manufacturing year of vehicle shall be November-2020 onwards & the vehicle prior to year November-2020 will not considered).
- 8) Bidders have to pay enquiry fee Rs.118/- and submit the original money receipt along with quotation.
- 9) The vehicle should have valid Fastag.
- 10) The period for hiring of vehicle will normally be 12 months from the date of engagement of vehicle, however if MSETCL vehicle is allotted by C.O Mumbai the hired vehicle will be discontinued by giving 15 days notice.
- 11) The responsibility of comprehensive insurance, PUC, tax permit & RTO formalities will be with vehicle provider.
- 12) Separate vehicle diary/Logbook will be maintained by the contractor for the account of Km run/day etc. for hired vehicle.
- 13) Payment will be effected on per month basis within reasonable period after making SES in SAP system by concern officer Incharge.
- 14) Quotation must be submitted along with the attested Xerox copies of all the documents pertaining to the vehicle such as **i) Vehicle registration documents ii) Vehicle Fitness Certificate iii) Valid vehicle Insurance iv) Valid PUC v) Driving License vi) PAN Card copy vii) Valid Fastag etc.**
- 15) The vehicle must be in the name of bidder/owner if not the owner must give declaration that he has permitted the bidder to rent out the said vehicle.
- 16) Notwithstanding anything contained herein the Company's general terms and conditions of contract shall be applicable to this contract.
