With reference to above subject, sealed and super scribed quotations are invited for the above mentioned work as per enclosed specification in Schedule-A. You are requested to quote lowest possible rates for the subject work as per specification in Schedule-A with following terms and conditions.

TERMS AND CONDITIONS:

1. The quotation must be submitted in two bid system sealed envelope duly super scribed with all details as Mentioned below.

2. Per day rates quoted should include provision of driver with his salaries & allowance. Vehicle maintenance, repairs & other Govt-Non Govt charges on account of vehicle, oil (Lubricant), Taxes and all other charges etc. including GST Tax. No extra charges will be paid. The rates shall be quoted in words and in figure. The rates are accepted on firm quotation basis.
3. Your quotation should reach this office on or before date:26.11.2025 by 12:00 Hrs and the same shall be opened at 14:00 Hrs. on the same day, if possible.
4. The order is limited to the period of one year and work order amount is at actual including all taxes from the date of engaging the vehicle whichever is earlier.
5. The rates are valid for twelve month from date of engaging of vehicle.
6. Separate vehicle diary will be maintained by you as prescribed by the undersigned for the account of Diesel, Km. Run/Day etc. for this hired vehicle.

7. All the charges for running vehicle shall borne by the vendor. Total value of work order will be limited to Rs.6,00,000.00/(Rupees Six Lakhs Only). Monthly expenditure is restricted to Rs. 50,000/- per month including Taxes. The vehicle will be engaged for maximum 25 days per month OR 2000KMs per months whichever is exhausted earlier.
8. The vehicle should be registered to FasTag so that on any Road Toll Plaza we should pass with FasTag Lane and charges of Road Tax Toll which are paid from FasTag will be borne by agency.
9. The vehicle owner should arrange the portable fire extinguisher in the vehicle compulsorily.
10. The work contract tax if applicable will be deducted from your bill as per rule.
11. According to the financial Act income tax will be deducted from your Bill at the rate of rule applicable of the contract value and certificate to that effect will be issued to you.
12. The MSETCL will not be responsible for any kind of accident or damages to the vehicle by driver during the hired period.
13. All the financial liabilities arising out of accident shall be borne by the owner of vehicle as per the prevailing "Workman's Compensation Act".
14. In case of failure/maintenance of vehicle you will have to provide another vehicle on same terms & conditions and rate. If Duration of this type of failure/maintenance exceeds 10 days then the contract may terminated with the forfeiting of S.D. If you fail to make such arrangement, department shall make the arrangement at your risk & cost.
15. Any kind of vehicle breakdown should be attended by owner of vehicle. No charges will be paid by MSETCL during breakdown. Agency will have to provide alternate vehicle during breakdown.
16. The working hours will be normally from 09:00 Hrs to 20:00 Hrs or as per directives of undersigned. However vehicle will be under MSETCL service for 24 hrs. The use of vehicle will be as per instruction of the undersigned or as and when required. However, no extra charges will be paid if in case vehicle will be utilized more than above period. Also in case of halt, no halting charges will be given to you.
17. Normally the service of the vehicle will not be used on Sunday and holidays. But if required you have to make vehicle available on Sunday and holidays. The payment will be made for day on which vehicle is used. No payment will be made for the days when the vehicle is not required for MSETCL during the period of hire.
18. Agency should have to submit the attested Xerox copies of documents listed below:-
 - a. R.T.O. tourist permit,
 - b. valid insurance certificate,
 - c. vehicle taxes,
 - d. RC,
 - e. TC book duly filled
 - f. last tax paid details,
 - g. fitness certificate,
 - h. PUC certificate etc.*Certificate accordingly should be attached with the Tender Form.
 - i. PAN NO.
 - j. Firm's details Ownership or partnership deed. Attach relevant documents (If applicable)
 - k. Proof of GST registration.(If not applicable Certificate/ Undertaking accordingly should be attached with the Tender Form)

The quotations without the above-mentioned documents are like to be rejected.

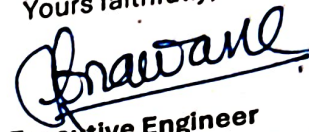
19. Driver should be managed by vehicle owner. He should have valid license to drive such type of vehicle. The driver should be polite in behavior and should not be drunker / smoker. The driver has to submit medical fitness certificate and has to maintain the vehicle dairy daily. Any misbehavior of driver reported by MSETCL's staff will be views seriously & you should provide alternate driver under such circumstances.

20. Manufacturing and registration year of vehicle should not be earlier than year **2020**. The vehicle should be in good condition having manufacturing year of **2020** or onwards. The model of vehicle which is being hired should be latest and in any case it should not be more than five year old from the date of manufacture of vehicle on the date of opening of quotation, if vehicle proposed is manufactured older than five years then joint inspection certificate of concern Engineer Incharge and the Executive Engineer, 400KV RS O&M Dn BBLR shall be submitted regarding suitability / physical condition and fuel efficiency of that vehicle.
21. In case of difference of opinion, about interpretation of terms & conditions between Owner /Agency & MSETCL, the decision of order placing authority will be final & binding on the Owner / Agency.
22. Any dispute/differences arise will be subjected to Jurisdiction of Hon. Ahamadnagar court only.
23. Bidder should not submit "Conditional Quotation" Such conditional offer shall be liable for rejection.
24. The successful bidder shall also execute a stamped contract agreement with the MSETCL at 400KV R.S. O&M Division, MSETCL, Babhaleshwar on his own cost in the Company's standard forms as per the provision of "Mumbai Mudrank Adhiniyam 1958, Clause No. 34". The contractor shall enter into an contract agreement with the MSETCL within seven days from the date of receipt of LOI of said contract. The MSETCL will not be liable to pay nor shall the contractor be entitled to claim any bill amount due or payable under the contract until the agreement is executed with MSETCL. The necessary stamp duty for the agreement shall be borne by the contractor.
25. The expenditures of hire vehicle is restricted to Rs.50,000 (Rs.Fifty thousand only) per month including of hiring charges, fuel cost (Diesel) & Taxes (like GST) etc. The monthly expenditure above Rs.50,000.00 (hiring + fuel charges+ taxes) will not be paid to you by M.S.E.T. Co. Ltd.
26. The owner/agency will be responsible for all risks that may arise during hiring period & vehicle operation.
27. All the rules regarding registrations of vehicle, sales tax, GST Tax & other Govt taxes etc. should be borne by vehicle owner.
28. The insurance of the vehicle should be arranged by agency. The same should be valid during contract period.
29. The vehicle of owner if wants any clarification regarding any terms of condition, he should approach in writing to undersigned before quoting rates.
30. After due date no clarification will be given and the decision of undersigned will be final and binding to all the vehicle owners quoting for said work.
31. The work shall be supervised by Engineer In charge, appointed by undersigned and it should be carried out to the satisfaction of Engineer in charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
32. The agency has to prepare monthly Bill in triplicate copies as per completion of work. Monthly Bill payment will be paid to you by account payee cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per measurement recorded in SAP i.e. SES. Payment will be made only for the days of actual hiring of Vehicle for Company's use only.
33. M.S.E.T.Co.Ltd. reserves rights to add or delete terms during the contract period if found necessary.
34. The air conditioner (A.C.) should be in working condition & will be used by officials as & when required.
35. Undersigned reserve the right to reject any or all the quotations without assigning any reason thereof.
36. All payments such as penalty of RTO should be borne by you.
37. Vehicle should be on the name of contractor. The entire document related with vehicle should be on the name of contractor/tenderer.

38. The contract can be terminated by the authority at any time, without assigning any reason therefore.
39. If it is found that vehicle is not giving satisfactory service. The contract is liable for cancellation after giving 10 days notice with the forfeiting of S.D.
40. Security deposits: The successful contractor shall have to deposit the security deposit of 05% of the work order value in the form of DD/BG/cash/ FDR within 7 days from the date of receipt of LOI. The same shall be refunded to you after satisfactory completion of total work and by obtaining NOC from Engineer Incharge and refunded to you as per availability of fund.
41. The validity of your offer should be for one year.
42. The vehicle will be used in Jurisdiction of Ahmednagar and Nashik District. If required the vehicle shall be utilized beyond Jurisdiction of above mentioned district.
43. The taxes like GST will be applicable as per privilege rates & rules circular issued by Govt time to time.

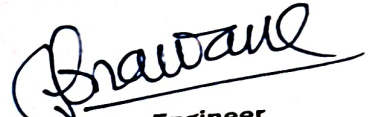

Preamble:-

With reference to the above subject, it is hereby submitted that, the additional Executive Engineer, Line Maintenance S/Dn, 400kV Babhaleshwar has submitted requirement of Hiring of Additional outsourced Light Vehicle (Bolero/Utility/Tata yodha) along with driver on hired (per day) basis to the 400kV Line Maintenance Sub Division, Babhaleshwar under 400kV R.S. (O&M) Division, Babhaleshwar. Vide under ref.

In connection with the above subject, it is put to your kind notice that our 400kV line maintenance subdivision having 09Nos of 400kV Lines which covers total 581 ckt km. There are total 1178Nos of towers in our jurisdiction of 400kV R.S Division Babhaleshwar.

To carry out routine, Diagnostic and breakdown maintenance work Light Motor vehicles are necessary. As our 400kV lines are passing through various terrain/Hilly areas. Hence, we have to carry out the line maintenance activities at various unapproachable hilly areas, agriculture land and hard locations. It is necessary light vehicle to approach at site by Narrow size road and route in emergency situation. Along with Diagnostic testing work such as Thermovision, TFR, patrolling work shall have to be done by Light vehicle only. In view of large geographical Jurisdiction, these Lines cover major portion of Nashik and Ahamednagar District from Nandgaon (Dist-Nashik) to Bota (Tal-Sangamner) which is huge area,It is required minimum 3 Nos of outsource light vehicle to attend Line maintenance Activities.prevoius year engaged additional vehicle.

This office have already engaged 02 Nos. Light vehicle Reg No. MH17 BY 9133 & MH 17 CV 5133 for various line maintenance activities. At present, 400kV LMSD Babhaleshwar having Total 18 Nos of Employees working, at the time of site work there are limitations for travelling no. of employees through existing Light vehicle.

Therefore, it is requested to arrange to issue permission to hire Additional outsourced Light Vehicle (Bolero/Utility/Tata yodha) along with driver on hired (per day) basis to the 400kV Line Maintenance Sub Division, Babhaleshwar under 400kV R.S. (O&M) Division, Babhaleshwar.

Propsoal for hiring of vehicle:-

400 KV Receiving Substation Babhaleshwar is one of oldest and one of the most important sub-stations in the MSETCL. This Substation also comprises 22 No. of 400KV Bays & 22 No of 220KV Bays. The transformation capacity of the substation to 2133MVA.

The sub-station old one and most critical S/S for MSETCL. The Substation was commissioned before more than 37 years & already completed significant service life.

As per MERC guidelines it is mandatory and essential to maintain the availability of all the lines and equipment' in the most appropriate condition at all times. As the substation is commissioned more than 37 year; most of the lines are very old.

The 400KV Babahleshwar substation is connected in grid and supplies power to major areas under Mumbai, Ahmednagar, Nashik, Pune and Aurangabad Districts.

It is connected to 400KV Grid via 400KV Dhule Ckt- 1 & 2, 400KV Aurangabad (Waluj), 400KV Bhushawal, 400KV Ektuni ckt-1&2, 400KV Padghe Ckt-1 & 2. It is connected to 220KV grid connected through 220KV substations via feeder Ahmednagar ckt- 1 & 2, Nashik ckt- 1 & 2, Challsaon, Alephata, Ranjangaon, Bhenda, DeaogaonRagari, Babahleshwar Ckt- 1 & 2 and 220kV Kopergaon Ckt- 1 & 2.

Due to the recent advancement and industrialization; the power demand has increased in Maharashtra. There is no relief in the loading of existing lines. The 400kV Padghe 1 & 2 are major export lines. The 400kV Ektuni 1 & 2 are major import lines.

One single line Subdivision is taking care of such 9 lines and maintain 1178 location i.e. 581KMs. This causes very much burden during the pin pointing the cause of tripping. Only less than 03 number of tripping are allowed on 400kV lines. Due to such vast area and network it is not practically possible to maintain the lines.

It is hereby proposed that, one additional vehicle i.e. 2+1 needs to be engaged considering the above scenario.

The permission for engaging vehicle for Work of bring outsourced LMV Vehicle car (petrol CNG)/Maruti Swift Dzire/Honda Amaze or equivalent vehicle along with driver to Executive Engineer, 400kV R.S. Division Babhaleshwar vide letter under ref. 11). Same was submitted for approval to C.A. vide ref (2).

Accordingly, vide letter under ref. (4), considering the urgency of the work the Competent Authority has given approval permission for hiring of additional outsourced Light Vehicle (Bolero Utility/Tata yodha) along with driver on hired (per day) basis to the 400KV LMSD. Babhaleshwar under 400kV R.S. Division, Babhaleshwar as per G.O.1 (F&A) dt. 14.10.2024, section (IV) (miscellaneous matters), Clause No. 24 for MSETCL works

It is requested to process the proposal as per routine procedure of MSETCL, Also, circulars in continuation to this issued till date shall be followed. Specifically Circular No. MSETCL/Dir(F)/No.4815 dtd.06.05.2016 and circular No. MSETCL/CO/CE/(O&M)/SE-II/EE VIII-6826 dtd 22.06.2016 shall be strictly followed for hiring of vehicle for office use. Any legal complication arises if any shall be the responsibility of your office.

Administrative approval:-

The C.A. has approved the Work of providing of hiring of additional outsourced Light Vehicle (Bolero/Utility/TATA Yodha) alongwith driver on hired per day basis for the 400kV Line Maintenance Sub Division, Babhaleshwar under 400kV R.S. (O&M) Division, Babhaleshwar vide under ref. for an amount of Rs.5,92,043.00/-

Propsoal:-

Considering the urgency, manual enquiry may be called and approval of draft work order may be obtained from the higher offices, please. The previous draft enquiry used for Hiring of LMSD vehicle is used.

Therefore, the work to be carry out on manual quotation basis as per instructions of higher offices in order to engage agency for the aforesaid works.

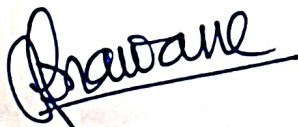
