- 2) The quantities mentioned in the attached schedule are approximate and likely to vary However, payment will be made as per the work actually executed and measured. The rates shown in enclosed schedule B are inclusive of GST.
- 3) The rates are inclusive of cost of all material, labour, plant, equipment, temporary works, tools, setting out, supervision, transportation, royalties, octroi and any local state or central

- 5) The work which is of bad workmanship quality will not be measured and paid.

- 7) The contractor will have to make good the damages if any made by him during the execution of work at his own cost.
- 8) The material should be got approved prior to fixing from the Engineer-in-charge.
- In accordance with provisions of section 194 (c) of the Finance Act, 1972, deduction of income tax at source at the rate of 2%, 1% cess on labour welfare, GST TDS at 2% and other taxes (laid down by central or state government) as applicable thereon or as per prevailing rate at the time of effecting payment, of the gross amount payable, shall be made from your running bills. Any other deduction, if required under any other finance acts shall also be made from your bills, unless you produces necessary exemption certificate.
- 10) Contractor will be held responsible for accident occurred during the course of the work and will have to pay the compensation as per the act 1923 and subsequent amendment thereof.
- Contractor should submit his bill in triplicate through Addl. Executive Engineer (Civil) EHV CCCM Sub-Division-II, Chhatrapati Sambhajinagar. Payment will be made within 60 days period from the date of receipts of bill to this office.
- 12) The terms and conditions in the M.S.E.T. Co. Ltd. Booklet 'Tender and contract work' will stand applicable for this work and final terms & conditions will be mentioned in Work Order.
- 13) You will have to pay any type of royalties of materials required for execution of materials. The rate in Work Order include Royalties also. You will have to submit receipts of Royalty paid at the time of submission of the bill.
