- 1. **Scope of work:** As per schedule "A".
- 2. The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR Supply of water through private connection from neighboring farmers for 400 kV R S Kumbhargaon, Nanded under 400 kV R S Division Kumbhargaon, Nanded. The quotation complete in all respects i.e. Offer rates should be filled in given work Schedule "A" format copy, Duly signed, sealed & super scribed, along with covering letter of bidder/agency with above mentioned subject. (Enquiry No. be quoted).
- 3. **Quoted Rate:** The Rate shall be quoted on firm quotation basis, for the particulars mentioned in Schedule "A". Taxes and charges should be mentioned clearly. If not mentioned, rate quoted will be considered as inclusive of all taxes.
- 4. Important Dates: Quotations invited from 27.11.2025 from 10:00 Hrs, so as to reach this office up to 11.12.2025 up to 17:00 hrs and the same will be Opened on the same day, if possible. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
- 5. **Taxes:** Taxes will be paid & recovered, as per rules.
- 6. Order Value: The order value is restricted to the amount of Rs.2,33,640.0 only(Incl. of GST).
- 7. **Period of Contract:** The period Contract will normally be 365 days from the date of issue of order or till order amount exhausts or local water arrangement made by MSETCL, then the services will be discontinued by giving 15 days' notice period.
- 8. **Payment:** The payment will be made on monthly 'RA' bill basis. Payment will be made after submission of that bill, the payment against this contract will be effected by MSETCL within reasonable time as per funds availability.



- 9. **Security Deposit:-** Security deposit i.e. 5% of order value to be paid within 7 days in terms of cash/DD to the office of the Executive Engineer, 400 kV R S Division Kumbhargaon, Nanded from the date of issue of order.
- 10. **Signing of Contract:-** Agreement contract between MSETCL authority & you should be carried out on Rs.500 bond paper within 7 days from the date of receipt of the work order. You will have to borne the charges for agreement bond.
- 11. Validity of Offer:- The offer should be valid for our acceptance for a period of 90 days from the Due date of same.
- 12.**Documents required:-** The rate offer must be accompanied with the following documents duly attested & signed by the Agency.
 - a. PAN card copy
 - b. 7/12 copy of duly singed by Talathi.
 - c. GST registration certificate (Optional)
- 13. You will have to provide water for minimum 5 Hrs daily or 15000 Liters to Kumbhargaon substation.
- 14. You will have to arrange 75mm water pipeline up to compound wall of 400kV R S Kumbhargaon, Nanded from your Borewell connection and any maintenance on water pipe line up to boundary wall.
- 15. **Insurance:** You will have to fulfil the requirement as per the circular no. ref.no.MSETCL/CO/C&M/PT/TKC-II/N0/8450, Dt.30/11/2022 & HO circular no. 7421 dt.18.10.2024, regarding taking insurance from directorate of insurance will be your responsibility & binding on you.
- 16. You will have to be done any breakage or leakage or any kind of maintenance issue of water pipeline from your borewell to compound of substation at your cost.
- 17. The MSETCL's general terms & conditions of work contract are applicable to this order.
