#### 9. WORK INSURANCE: -

It is mandatory for the contractor to obtain work contract insurance against work order i.e. Contractor All Risk Policy (CAR) from the Directorate of Insurance Maharashtra State with prevailing rate as per Govt. of Maharashtra GR. No. Sankirn 2018/Pra. Kra.47/CR-174/Vima Prashasan dtd. 13.07.2022 before commencing of work and a proof of the same should be submitted to this office.

10. Income tax/Work contract & any other statutory deduction at source will be deducted from your tax invoice as per prevailing rules. You have to produce GST number while claiming the tax invoice. Ex-works rate & GST Taxes extra should be quoted along with HSN code for supply & SAC code for works.

#### 11. GUARANTEE/WARRANTY

The material supplied should be guaranteed/warranted for minimum a period of twelve months from date of received to this office and should be replaced by the supplier, if within guaranteed period.

#### 16. PAYMENT

100% Payment will be made against Tax Invoice will be released after satisfactory completion of work and submission of bill in quadruplicate within 45 days after receipt of tax invoices & duly signed & recorded by authority subject to availability of funds and completion of all activities in ERP-SAP system.

#### 17. PENALTY

If the contractor fails to execute the work as per the scope of work within stipulated period as above penalty towards delay @ 1% per week maximum to the extent of 10% of order value will be levied and deducted from bill for non execution of the work.
