Document should upload the following digitally signed scan copies of documents /certificates online under

Technical Bid.

- Submit the performance /experience certificate along with order for ‘providing and fixing of materials related at substations’ in any Government /Private sector in India.
- The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer or equivalent. The bidder shall also submit the copy of the work order mentioned in the experience certificate as testimonials.

Commercial Bid.

- PAN Card of the firm/proprietor as the case may be. Income Tax return for last one year.

- Certificate of Registration for GST with latest paid Challan.
 - Shop Act License.
 - Annual Turnover for last 1 year duly certified by Chartered Accountant should not less than 60% of the estimated cost.
 - Net Worth of last 1 year duly certified by Chartered Accountant should not be less than 25% of estimated cost.
2. The Contractor rates should be in percentage (%) based on estimate cost.
 3. Rates should be valid for 120 days from the date of commercial opening of RFX.
 4. Rfx fee is Rs.118/- including taxes (Is nonrefundable).
 5. If the above documents are not applicable, then submit Eligible/ Non eligible documents list.
 6. Income Tax will be deducted from contractor's bill, as per Govt. rules
 7. Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
 8. **Scope of work: -**
Providing and Fixing of 39kV & 54kV Lighting Arrester at 400kV Substation, Padghe under 400kV RS (O&M) Dn, Padghe.
 9. **Delivery Period: -** The material should be supplied with 06 Months from the date of LOI/PO whichever is earlier. The Contractor will have to give a guarantee of work done by him for the period of 12 months from the date of work done at site.
 - 10) **Quality of Work: -** The material should be supplied as per specifications mentioned in Schedule. The sample should be got approved from Executive Engineer, 400kV RS (O&M) Dn, Padghe or his representative for material before delivery.
 - 11) **Dispatch Instructions: -** The material shall be dispatched and consigned to the 400kV RS (O&M) Dn, Padghe.
 - 12) **Warranty: -** The Contractor will have to give a warranty/ guarantee for material supplied for the period as specified by the manufacturer/OEM of the material from the date of receipt of material at site/ work place as the case may be. The warranty certificate should be given along with the material. If the OEM warranty is less than One year, the bidder shall give warranty of at least two years from supply of material.
 - 13) You will have to pay the security deposit of amount equal to 5%(Five) of the order value within 07 days from the date of issue of letter of intent / purchase order, in the office of the Superintending Engineer, HVDC RS (O&M) Circle, Padghe, Tal.
