4. Quantity:

The quantities mentioned are tentative and may vary on either side as per requirement.

5. Payment Terms:

100% payment shall be released after receipt of material and submission of GST invoice. Payment shall be made within 15 to 30 days, subject to availability of funds. No advance payment shall be given.

6. Taxes & Deductions:

Statutory deductions shall be made as per prevailing Government rules.

The supplied material/equipment shall carry a minimum warranty of 1 year from the date of supply.

8. Security Deposit:

5% Security Deposit shall be paid on the ordered amount. The same shall be refunded after successful completion of the warranty period.
