Scope of Work (Annexure-A)

<u>Subject</u>: Supply, Installation & Maintenance of 'Broadband Internet Connection' for the period of 'three years' at Administrative Building, Rasta Peth, MSETCL Pune – 411 011

1. Provision of Internet Bandwidth

The Service Provider shall provide an Optical Fiber based Broadband Internet connection with a committed bandwidth of **300 Mbps**.

2. Bandwidth Assurance

The Internet bandwidth provided shall **not degrade** below **200 Mbps** at any point of time, under normal operating conditions. The Service Provider shall ensure stable and consistent throughput.

3. Last Mile Connectivity

The Internet connection shall be delivered through dedicated optical fiber up to the premises of MSETCL Administrative Building, Rasta Peth, Pune, including all necessary last-mile infrastructure.

4. Router / ONT Provisioning

The Service Provider shall supply, install, configure, and maintain a managed Router / Optical Network Terminal (ONT) suitable for enterprise use.

5. IP Management Capability

The supplied Router / ONT shall support IP address management, including but not limited to: a) Static IP configuration b) NAT, DHCP, and basic routing functions c) Compatibility with existing LAN infrastructure

6. End Termination

The Internet connection shall be terminated on **RJ-45 Ethernet interface** for seamless integration with the existing LAN setup. This connection shall be terminated in **Firewall** & **IP provided by ISP's router/ONT** shall be **configured**. Service provider shall ensure this setup.

7. Service Availability & Uptime

The Service Provider shall ensure high availability of Internet service, with minimal downtime. Any planned maintenance shall be informed in advance.

8. Monitoring & Support: The Service Provider shall provide: a) Continuous monitoring of the link b) Technical support for fault resolution c) Defined response and restoration timelines for connectivity issues

9. Installation, Testing & Commissioning

Complete installation, testing, and commissioning of the Internet link and Router / ONT shall be carried out by the Service Provider, ensuring satisfactory performance before handover.

10. Maintenance Responsibility

The Service Provider shall be fully responsible for operation, maintenance, and troubleshooting of the Internet link and supplied equipment throughout the contract period.

11. Compliance with Security & IT Policies

The service and equipment shall comply with MSETCL's IT security policies and shall not adversely affect the existing network and security setup.

12.One Static public IP: Service Provider shall provide minimum One Static public IP for contract period.

13. Billing Frequency & Payment Clause (Quarterly Basis):

The Service Provider shall raise bills on a quarterly basis for the Optical Fiber based Broadband Internet service, after completion of each quarter of satisfactory service including taxes.
