**Sub: -E – Enquiry for AMC of Electrical Maintenance work for RTC Babhaleshwar on urgent basis**

Dear Sir,

Please offer your lowest and reasonable techno-commercial bids for the subject work as per the enclosed Schedule 'A'. The detailed scope of work is given below. Please Note the following.

**TERMS AND CONDITIONS:-**

Two bid systems should be followed for submitting the offer. The quotation must be forwarded to the office in the name of "The Executive Engineer, 400kV R.S. (O&M) Division, Babhaleshwar" in sealed envelope duly super scribed with all details:-

**A. Techno –Commercial bid:**

This should contain following documents certificates (all self attested copies) as a proof of qualifying pre-requisites, brochures, attested certificates etc.

- Valid Goods & Service Tax (GST) registration certificate.
- Copy of PAN card & ITR for last 3 years.
- Valid work compensation /insurance policy.
- Valid Shop Act Registration/ Gram Panchayat NOC.
- Authorization from OEM to supply the materials

**B. Commercial bid:**

Techno-commercial bid will be opened for qualified bidders only. After verifying the all documents /certificates submitted in techno commercial bid for prequalification as mentioned above, if it is found that, the Tenderer fulfills the desired prerequisites; the price bid will be opened. If the same is not found to be meeting the prerequisite, the commercial bid shall not be opened. Tenders with incomplete details or not submitted in prescribed tender form etc. are liable to reject.

- The quotation must be written with ink or typewritten, any scratching or over writing must be initialed.
- The validity period of rates should be mentioned in the offer which should be not less than 30 days from the date of opening of quotation.
- Income Tax & statutory taxes if applicable shall be deducted from your bills as per prevailing Government rules.
- Beside all the terms & conditions given in this enquiry, the Board's General Conditions of Contract are applicable to this contract.
- Rates should be quoted both in figures and words.
- GST No., PAN No., if any should be quoted on your quotation. Xerox copies of each should be attached to the quotation.

- vii. Details of Taxes if any should be mention clearly; otherwise, the rates quoted by you will be treated as inclusive of all taxes and no extra tax will be paid.
  - viii. Other charges shall be mentioned separately; otherwise, the rates quoted by you will be treated as inclusive of all charges and no extra tax will be paid.
  - ix. The rates should be on firm quotation basis & exclusive of all taxes and any other contingencies etc.
  - x. The rates quoted by you should be exclusive of GST in "Schedule- A". GST will be paid extra as per prevailing rules.
- 2) The work should be carried out strictly immediately. The work should be completed within given period. The necessary arrangement for outage will be done by respective engineer incharge.
  - 3) The work carried out should be as per the standard practices of MSETCL & material required for this work should be taken from MSETCL approved vendors only. The approved drawing for the said work is attached herewith and strictly instructed to do the work as per approved drawing.
  - 4) **SCOPE OF WORK:**
    - a. As per Schedule "A" & approved detail estimate attached herewith.
    - b. The contractor shall be fully responsible for compliance of all statutory obligations under the Factory Act 1948, Contract Labour (Regulation and Abolition) Act 1970, Maharashtra Labour Contract Regulation & Abolition Act, 1971, Minimum Wages Act, Provident Fund Act and ESIC Act / Workman Compensation Act 1926, Payment of Wages Act in respect of the Staffs deployed. The rules and regulation of the Contract Labour Act shall be binding on the contractor.
    - c. The Owner will not be responsible for violation of these statutory rules and regulations by the contractor.
    - d. It shall be the sole responsibility of the contractor to observe all the relevant acts and regulations along with amendments there to framed by the Government from time to time. The Owner shall not be responsible for violation of any of the above stated regulations / Acts etc. by the contractor.
  - 5) You will have to arrange all tools, plants, manpower etc. to carry out the work at your own cost.
  - 6) You will have to provide all safety measures to your staffs while executing the work in sub-station.
  - 7) **GUARANTEE: -**  
You should give guarantee of the work done against this work order, good quality & workmanship must be guaranteed for best performance at least for 12 months from the date of work done.
  - 8) The payment shall be made only after satisfactory completion of work as certified by the concern Engineer In-charge.
  - 9) **SECURITY DEPOSIT:**  
You will have to pay Security Deposit @05% of work order value within 10 days from the date of receipt of this LOI order or before starting of work whichever is earlier.
    - i. If SD is submitted in the form of FDR, then FDR duly discharged with Rs.1/- revenue stamp, official seal and signature of depositor on reversal side of FDR in favor of the MSETCL as given above on account of agency / vendor.
    - ii. If SD in form of BG then appropriate value of stamp duty shall be paid on executed amount of BG as per Maharashtra Stamp Act. The Bank Guarantee shall be on a Scheduled Bank / Nationalized Bank and it shall be valid until 90 days after the contract period and the claim period shall be for further 90 days.
    - iii. The S.D. paid will be refunded after **three months** from the date of completion of work satisfactorily. You have to apply to concern Division Incharge for obtaining NOC, after receipt of NOC, S.D. will be refunded as per availability of fund.
    - iv. The detail order will be issued only after the payment of security deposit.
    - v. If the successful Contractor fails to submit Security Deposit within the stipulated period, it will be presumed that the Contractor is not interested in execution of the contract and the work contract will be issued to other agency (i.e.). The decision of tender accepting authority i.e. the Executive Engineer, 400KV RS (O&M) Division Babhaleshwar shall be final and remain binding on the Contractor(s).
    - vi. No interest will be paid on the Security Deposit and the Security Deposit will be refunded after satisfactory execution of works / guarantee period, whichever is later.

**10) AGREEMENT & STAMP DUTY:-**

- a. The successful Contractor has to execute an Agreement with The Executive Engineer, 400KV RS (O&M) Division,



Babhaleshwar within 7 days after receipt of letter of intimation, the work order will be only issued after executing the Agreement & submission of security deposit.

- b. The successful Contractor shall submit an Agreement Bond on non-judicial stamp paper as per Mumbai Stamp Duty Act 1958, clause No. 34. The expenses towards the stamp paper and preparation of Agreement Bond will be on the part of the contractor.

11) The undersigned reserves the right to reject any or all the bids without assigning any reason whatsoever.

12) If the work is not carried out within the stipulated time / period, penalty @ ½% per week will be recovered from the contractor's bill subject to 10% maximum.

**13) LIABILITY OF ACCIDENT / LOSS:**

The contractor will be responsible for any accident to any of his personnel or loss to him during the work. The responsibility of the insurance towards the same shall be with the contractor. The compensation to the contractor's personnel will be the responsibility of the contractor.

**14) EXCEEDING THE CONTRACT VALUE:**

The contractor will have to watch and ensure that the total value of work carried out by him does not exceed the contract value. If the work / value of contract is likely to be exceeded the same should be brought to the notice of the undersigned in writing. If the value of the total work exceeds the order value in that case the contractor is not permitted to execute the work without prior permission from the undersigned.

**15) DAMAGE TO PERSONS AND PROPERTY:**

Contractor will indemnify the MSETCL against any losses and claims regarding any injuries or damage to any person, material or physically damage any property whatsoever which may arise out of or in consequence of the execution of work. During execution of work any damage/loss to Transmission Company's property occurs will be recovered from your bill.

**16) SUBLETTING OF THE CONTRACT:**

- a. The contractor will not sublet / transfer / assign the contract as a whole or any part or any operation thereof to any other party.
- b. In case the contractor sublets/ transfers / assigns the contract as a whole or any part it or any operation thereof to any other party, it will be treated as breach of contract and the contract will be terminated at contractor's risk and cost.

**17) Insurance:**

As per GR No. महाराष्ट्र शासन परिपत्रक क्र. संकीर्ण -२०१८ / प्र.क्र.४७ / विमा प्रशासन मंत्रालय मुंबई दि.१३.०७.२०२२, you have to submit the insurance from the Directorate of insurance, Maharashtra State, Gruhnirman Bhavan, 264, 1<sup>st</sup> Floor, In front of Kala Nagar, Bandra (East), Mumbai-400051 (Phone No.022-26590403/26590690) and Fax No.022-26592461 for work order amount to protect your interests and the interest of the MSETCL, against all risks as per the Contract of this bid valid upto the work order completion period. Any loss or damage to the material / equipment / manpower, during supply, handling, transporting, storage and erection, till such time the plant is taken over by the Owner shall be to the account of the bidder. The bidder shall be responsible for lodging of all claims and make good for the damage or loss by way of repairs and / or replacement of the portion of the works damaged or lost. The transfer of title shall not in any way relieve the bidder of the above responsibilities during the period of the bidder. The said insurance should be in line with the terms & conditions of MSETCL Letter No. MSETCL/CO/C&M/PT/ TKC-II/No.8450 dtd-30.11.2022. It is responsibility of the contractor to takeout all necessary insurance of material/equipment/labour for execution of work for his liabilities direct/indirect and same must be attached with the invoice otherwise 0.5% on work order value will be deducted from your bill and said payment of amount will be made to the Directorate of insurance, Maharashtra State, Mumbai.

18) Quantities shown are tentative & subject to variation on either side.

19) **VALIDITY OF ORDER:** The order will be valid for until exhausting of the order amount or 120 days from the date of Lol whichever is earlier.

20) Income Tax & statutory taxes as applicable shall be deducted from your bills as per prevailing Government rules.

**21) CONTRACTOR'S DEFAULT:**

- a. In case you fail to complete work fully OR partially, the security deposit will be revoked by MSETCL. In this case the balance work will be got done from other agency may be at higher rates and the difference in cost will be recovered from the contractor's bills.
- b. In case of any loss / damage to the Owner's asset /material, it will be the sole responsibility of the contractor to lodge the complaint in writing to the nearest police station under intimation to this office or to In-charge/ designated officer.

- c. If there happens any loss of goods or damage to valuable material in the premises on account of negligence of the Staff, the cost of loss / damage shall be recovered from the contractor.

**22) SUSPENSION / HOLDING OF WORK:**

If the work has to be suspended due to any reason i.e. stay order from court of law, legal held up from any other Agency, shut down etc. the MSETCL shall not pay any compensation / damage to the contractor towards item like idle labour, etc. In such cases the contractor is not liable for claiming extra payment.

**23) DEDUCTION:**

Any Amount which become payable by the contractor to the MSETCL under particular contract will be deducted by the Owner from any amount due or becoming due to him to the contract under the same or any other contract.

**24) SAVE AND EXCEPT:**

Amount due to account of damage or compensation for default or breach of contract by the contractor in which case instead of deduction of the same amount shall be retained and the Owner shall have the right on amount so retained or withheld.

**25) TERMINATION OF CONTRACT:**

The Undersigned reserve the right to terminate the contract at any stage without assigning any reasons thereof.

**26) GENERAL:**

The Contractor are also deemed to be fully aware of the company's general conditions of contract for work, supply of equipment/material and any ignorance of any of the condition will not exempt you from liability to abide by the same.

27) Validity period of offer should not less than 120 days.

**28) JURISDICTION:**

All disputes or difference arising out of and in connection with the contract shall be subject to the exclusive jurisdiction of Ahilyanagar Court only.

29) The period for enquiry submission is from 05.01.2026 to 12.01.2026 @ 14.00Hrs., please note.
