With reference to above subject, sealed and super scribed quotations are invited for the above mentioned work as per enclosed specification in Schedule-A. You are requested to quote lowest possible rates for the subject work as per specification in Schedule-A with following terms and conditions.

TERMS AND CONDITIONS:

1. The quotation must be submitted in **two bid system sealed envelope** duly super scribed with all details as Mentioned below.

2. Per day rates quoted should include provision of driver with his salaries & allowance. Vehicle maintenance, repairs & other Govt-Non Govt charges on account of vehicle, oil (Lubricant), Taxes and all other charges etc. including GST Tax. No extra charges will be paid. The rates shall be quoted in words and in figure. The rates are accepted on firm quotation basis.
3. Your quotation should reach this office on or before **date:14.01.2026 by 12:00 Hrs** and the same shall be opened at 14:00 Hrs. on the same day, if possible.
4. The order is limited to the period of one year and work order amount is at actual including all taxes from the date of engaging the vehicle whichever is earlier.
5. Per day rates quoted should include provision of driver/operator his salary & allowances. Crane / excavator maintenance, repairs & other Govt. and Non Govt. charges on account of crane / excavator, oil (Lubricant), taxes and all other charges etc. including GST Tax. No extra charges will be paid. The rates are accepted on firm quotation basis.
6. The rates are valid for one year from date of engaging of crane / excavator.
7. Separate crane / excavator diary will be maintained by you as prescribed by the undersigned for the account of usage.
8. The work contract tax if applicable will be deducted from your bill as per rule.
9. According to the financial Act income tax will be deducted from your Bill at the rate of rule applicable of the contract value and certificate to that effect will be issued to you.

10. The MSETCL will not be responsible for any kind of accident or damages to the crane / excavator or driver /operator during the hired period.
11. All the financial liabilities arising out of accident shall be borne by the owner of crane / excavator as per the prevailing "Workman's Compensation Act".
12. In case of failure/maintenance of crane / excavator you will have to provide another crane / excavator on same terms & conditions and rate. If Duration of this type of failure/maintenance exceeds 10 days then the contract may be terminated with the forfeiting of S.D. If you fail to make such arrangement, department shall make the arrangement at your risk & cost.
13. Any kind of crane / excavator breakdown should be attended by owner of crane / excavator. No charges will be paid by MSETCL during breakdown. Agency will have to provide alternate crane / excavator during breakdown.
14. Normally the service of the crane / excavator will not be used on Sunday and holidays. But if required you have to make crane / excavator available on Sunday and holidays. The payment will be made for day on which crane / excavator is used. No payment will be made for the days when the crane / excavator is not required for MSETCL during the period of hire.
15. Agency should have to submit attested Xerox copies of all documents related to crane / excavator viz:
 - a. R.T.O. R.C., valid insurance certificate, crane / excavator taxes, TC book duly filled with last tax paid details, fitness certificate, Driver / operator license, PUC certificate and all relevant documents, etc. Certificate accordingly should be attached with this.
 - b. PAN NO.
 - c. Firm's details Ownership or partnership deed. Attach relevant documents (If applicable)
 - d. Proof of GST registration. (If not applicable Certificate/ Undertaking accordingly should be attached with this)

The quotations without the above mentioned documents are liable to be rejected.

16. Driver should be managed by crane / excavator owner. He should have valid license to drive / operate such type of crane / excavator. The driver / operator should be polite in behavior and should not be drunker / smoker. The driver has to submit medical fitness certificate and has to maintain the crane / excavator dairy daily. Any misbehavior of driver reported by MSETCL's staff will be viewed seriously & you should provide alternate driver under such circumstances.
17. The registration year of crane / excavator should not be earlier than year 2018. The crane / excavator should be in good condition having manufacturing year of 2018 or onwards. The model of crane / excavator which is being hired should be latest and in any case it should not be more than five years old from the date of manufacture of crane / excavator on the date of opening of quotation, if crane / excavator proposed is manufactured older than five years then certificate of concern End user and the Executive Engineer/400KV/RS/Dn/BBLR shall be submitted regarding suitability / physical condition and efficiency of that crane / excavator.
18. In case of difference of opinion, about interpretation of terms & conditions between Owner /Agency & MSETCL, the decision of order placing authority will be final & binding on the Owner / Agency.
19. Any dispute/differences arise will be subjected to jurisdiction of Ahilyanagar only.
20. Bidder should not submit "Conditional Quotation" Such conditional offer shall be liable for rejection.
21. The successful bidder shall also execute a stamped contract agreement with the MSETCL at 400KV R.S. O&M Division, MSETCL, Babbhaleshwar on his own cost in the Company's standard forms as per the provision of "Mumbai Mudrank Adhiniyam 1958, Clause No. 34". The contractor shall enter into a contract agreement with the MSETCL within seven days from the date of receipt of LOI of said contract. The MSETCL will not be liable to pay nor shall the contractor be entitled to claim any bill amount due or payable under the contract until the agreement is executed with MSETCL. The necessary stamp duty for the agreement shall be borne by the contractor.
22. The owner/agency will be responsible for all risks that may arise during hiring period & crane / excavator operation.
23. All the rules regarding registrations of crane / excavator, sales tax, GST Tax & other Govt taxes etc should be borne by crane / excavator owner.
24. The insurance of the crane / excavator should be arranged by agency. The same should be valid during contract period.
25. The crane / excavator owner if wants any clarification regarding any terms of condition, he should approach in writing to undersigned before quoting rates.
26. After due date no clarification will be given and the decision of undersigned will be final and binding to all the crane / excavator owners quoting for said work.

27. The work shall be supervised by concern Engineer Incharge, appointed by undersigned and it should be carried out to the satisfaction of Engineer In charge. In case of any dispute, decision of undersigned shall be final and binding on the contractor.

28. The agency has to prepare monthly Bill in triplicate as per completion of work. Monthly Bill payment will be paid to you by account payee cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per measurement recorded in SES by Concern Engineer Incharge. Payment will be made only for the days of actual hiring of Crane / excavator for Company's use only.

29. M.S.E.T.Co.Ltd. reserves rights to add or delete terms during the contract period if found necessary.

30. Undersigned reserve the right to reject any or all the quotations without assigning any reason thereof.

31. All payments such as penalty of RTO should be borne by you.

32. The entire document related with crane / excavator should be on the name of contractor.

33. The contract can be terminated by the authority at any time, without assigning any reason therefor.

34. If it is found that crane / excavator is not giving satisfactory service. The contract is liable for cancellation after giving 10 days notice with the forfeiting of S.D.

35. Security deposits: The successful contractor shall have to deposit the security deposit of 05% of the work order value in the form of DD/BG/cash/ FDR within 7 days from the date of receipt of LOI. The same shall be refunded to you after satisfactorily completion of total work and by obtaining NOC from Engineer Incharge and refunded to you as per availability of fund.

36. The validity of your offer should be for One year.

37. The taxes like GST will be applicable as per privilege rates & rules circular issued by Govt. time to time.

Preamble:-

400 KV Receiving Substation Babhaleshwar is one of most important stations in the MSETCL grid and Highest MVA Capacity 400/220KV, 2133 MVA gives it the stature of highest installed capacity 400 KV Substation in Maharashtra. There are 24 No of 400KV Bays & 22 No of 220KV Bays. The sub-station is one of the oldest and the most critical S/Stn for MSETCL As this 400KV Babahleshwar substation connected in grid having feeding power to the area under Ahmednagar, Nashik, Pune and Aurangabad Districts. On 400KV side the 400 KV RS Babhaleshwar is connected in Grid By 400KV Dhule-1&2, 400KV Aurangabad(Waluj), 400KV Bhushawal, 400KV Ektuni-1&2, 400KV Padghe-1&2 and 220KV Grid connected to 220kV substation via feeders Ahmednagar-1 & 2, Nashik-1&2, Chalisgaon, Alephata, U Tech Sugar, Behnda, DeogaonRangari, Babahleshwar-1& 2.

The substation is very old and commissioned in 1985 i.e. most of the equipments have completed 38 years of life. It is very necessary to keep the equipments in healthy condition by doing routine maintenance and also the duration of shutdown and breakdown should be minimum so that the interruption time is less and no major disturbance is caused in the grid. There is requirement of Crane for lifting various equipments for routine servicing and replacement at times. There is requirement of crane for lifting of CT, PT, Circuit Breakers, ICT Turrets for attending the issues and maintenance if required and lifting of material from maintenance store to switchyard, lifting of cable drums, rearranging of inventory, lifting of old/scrap material/panel etc. Also, there is requirement of Crane in case of emergency so that the breakdown time can be reduced. As the substation is very large there is requirement of Crane for material movement and material shifting. Also, to maintain this large area of the substation JCB services are required for trimming/cutting trees.

Considering the large area and 46 no. of bays, for day to day maintenance, there is urgent requirement of crane and JCB services at 400 KV RS Babhaleshwar. The hiring of Crane and JCB will save the time required for enquiry and calling also, the emergency charges will be avoided.

Hence, Work of hiring of Crane and Excavator (JCB JS 80) services with operator as and when required on per hour basis at 400KV R.S. Babhaleshwar under 400KV R.S. (O&M) Division Babhaleshwar.

The 400KV RS, DN, Babhaleshwar have considered the Work of hiring of Crane and Excavator (JCB JS 80) services with operator as and when required on per hour basis at 400KV R.S. Babhaleshwar under 400KV R.S. (O&M) Division Babhaleshwar.

Various outages and material transport form store to the switchyard and vice versa is required. Now, days for the 76Hector area also JCB and crane services required for big trees, shrubs and avoiding manual labours.

The crane of 400KV BBLR is crapped and no suitable crane operator is available in 400kV. The existing W.O. is exhausted upto 3.29Lkahs and billing of 1.25Lakh is under process.

Thus, few amount is balance in hand and various works in the 400kV are ongoing. The proposal is submitted for approval of administrative approval. This proposal is prepared considering the benefits of MSETCL.

Administrative approval:-

The C.A. has approved the Work of hiring of Crane and Excavator (JCB JS 80) services with operator as and when required on per hour basis at 400KV R.S. Babhaleshwar under 400KV R.S. (O&M) Division Babhaleshwar vide under ref. for an amount of Rs.5,00,000.00/-

Proposal:-

Considering the urgency, manual enquiry may be called and approval of draft work order may be obtained from the higher offices, please.

Therefore, the work to be carry out on manual quotation basis as per instructions of higher offices in order to engage agency for the aforesaid works.

Approval of Competent Authority:

As per powers delegated vide GO1 Edition 3, Dtd. 14.10.2024, Section II-Works, Clause No. 5, page 27 of 69, the Executive Engineer in consultation with Dy. Manager(F&A) is empowered for Invitation and opening of tenders upto Rs.50Lakhs.

As per powers delegated vide GO1 Edition 3, Section II-Works, Clause No. 7, page 32 of 69, the Superintending Engineer in consultation with Manager(F&A) is empowered for Awarding contract for works through quotations / e enquiry in case of urgency awarding works through quotation subject to the permission for under this clause shall not 20% of approved budget under circle.

As per MSETCL/CO/CE(O&M)/SE-II/EE-VIII/6826 dtd:22.06.2016, hiring of vehicle is this work is exempted from SRM e-tendering system.

The e-enquiry shall be floated, Hence, the Executive Engineer, is hereby requested to issue permission to float the manual enquiry for casual contract.


