TERMS & CONDITIONS

- Name of Work:-** Providing of Electric Vehicle/ LMV (without fuel) such as (Swift Dzire/Zest /Amaze /Ciaz /Nexon/Altroz/or Equivalent) alongwith driver for Ex. Engineer, EHV Projects Dn-III, Solapur.
- The Vehicle should be in good running condition i.e. tyre, all meter, cushion, viper, INDICA or etc must be in working & good condition before date of Enquiry. However the preference will be given to latest model/manufacture.
- The Vehicle along with Driver should present as & when required and as per intimation of Engineer In-charge or undersigned.
- Payment of driver should be borne by agency. The Driver has to maintain the vehicle diary daily.
- During the vehicle on road if any problems related to vehicle arises, it is owners responsibility to arrange another vehicle or to resolve the problem. The cost of lubricating oils i.e. engine oil, break oil and other spares will be borne by owner.
- The quotation not confirming to specifications detailed in schedule "A" are likely to be rejected.
- Income Tax & GST if applicable will be deducted at prevailing rate for every month.
- You will have to pay S.D. at the rate of 10% of value of the contract by Bank Guarantee/F.D.R. of the work order value within 07 days from receipt of order. If not paid within 7 days, SBIPLR interest including 18% will be charged from the 7th day and S.D will be recovered from 1st & 2nd bill.
- The vehicle will be utilized on any day of the week & the same has to be made available with a short notice of the undersigned/officer in-charge. Further vehicle will be given off on any day without assigning any reason for which no charges will be paid for that day/days.
- Quotation should reach to this office on or before **dt-20/01/2026 up to 17:00Hrs.**
- If the vehicle failed on the road, non use of hour will be counted proportionately from the daily bill.
- Execution of agreement on Rs. 800 stamp paper is essential.
- The following should be clearly mentioned on the sealed envelope:-
 "Quotation for Providing of Electric Vehicle/ LMV (without fuel) such as (Swift Dzire/Zest /Amaze /Ciaz /Nexon/Altroz/or Equivalent) alongwith driver for Ex. Engineer, EHV Projects Dn-III, Solapur."
- "Schedule A" and quotation should be submitted on agency's letter head and as per prescribed format.

15. Executive Engineer reserves the right to reject any or all the quotations without assigning any reason.
16. The period of order will be from Dt-01/04/2026 up to full utilization of work order value from the date of placement of order or date 31/03/2027 whichever comes earlier.
17. The Driver shall be well behaved, neatly dressed & possessing valid driving license of transport vehicle & the driver should be free from alcoholic & smoking addictions.
18. Consuming fuel shall be supplied by MSETCL.
19. The jurisdiction of the vehicle is normally Solapur district, but this office secure the right to use the vehicle anywhere in Maharashtra Jurisdiction as and when required.
20. MSETCL shall not be responsible for driver's liability such as accident compensation, wages, accommodation and other facilities etc.
21. The contract can be terminated by the authority at any time, without assigning any reason by giving one day advance notice.
22. Sealed envelope containing Xerox copies of qualifying documents is to be submitted without fail as below:
 - i) Valid Vehicle Permit,
 - ii) Valid Vehicle Insurance,
 - iii) Valid All Taxes paid certificate
 - iv) Valid PUC,
 - v) RC Book,
 - vi) Valid Fitness certificate
 - vii) GST Registration certificate if applicable
 - viii) Valid Shop Act
 - ix) Valid Transport Driving license
 - x) PAN card copy

Any quotation not accompanied by the said documents shall be rejected and will not be taken into consideration under any circumstance whatsoever.

23. The quoted per day rate should be inclusive of per day rate, OT & halt charges. No extra charges will be paid other than this.
23. As per GR 'शासन निर्णय क्र.मइवाधो-२०२१/प्र.क्र.२५/तां.क्र.४ दि.२९/१२/२०२१' from Government of Maharashtra vehicle operating on Electricity are to be hired hence, Electric Vehicle will be preferred and if quotations are not received for Electric Vehicle then, CNG/Diesel/petrol operated Vehicle will be considered.
24. In case of the difference of opinion about the interpretation of terms & conditions between you & MSETCL the decision of the undersigned will be final & binding upon you.
25. Work order value limit for each month is Rs.50,000/- (including fuel, all taxes & Hiring charges).
