- 2.Quotations with incomplete details or not submitted within due date etc. are liable to reject.
- 3.This office reserves all the rights to reject any or all quotations without assigning any reason thereof.
- 4.Rates quoted shall be inclusive of all taxes, Transportation, Loading, Unloading and other incidental charges. Nothing extra on any account will be paid.
- 5.No material will be issued by the Company.
- 6.You will have to supply the tea/coffee machine within 30 days from the date of issue of work order/LOA.
- 7.If any damage occurs to the Company's property during execution, contractors will have to make it good at his own cost.
- 8.If any accident occurs to contractor's personnel during the execution of work, the company will not be responsible for the payment of any compensation to them. In such cases, it will be the contractors responsibility to pay the compensation as per the workmen Compensation act and the rules made under.
- 9.You have to remit, Security Deposit @ 5% of the total value of the work order in this office by D.D./ B.G./ fixed deposit in nationalized or scheduled bank after acceptance of order & before execution of work. If you fail to do so, the SD will be recovered from your first bill with interest. The S.D. will be refunded after the completion of guarantee period.

10.If you fail to execute work within stipulated Time, penalty @ 1/2% per week, maximum to 10% of order amount shall be levied on contract value & GST applicable on LD amount.

11.You shall not entrust the work on sub-contract /transfer or assign the contract or any part thereof to any third party. In case any deviations observed it will be treated as breach of contract and the contract will be terminated at your entire risk and cost.

12.You should be fully aware of the MSETCL's General Condition for execution of work and same is applicable to this contract also.
