1	PRICES :	The rates will be accepted as per Schedule A with Providing & configuration of Ethernet Switch for SAS/SCADA system at 220kV Jath Substation
2	SCOPE OF THE WORK :	Providing & configuration of Ethernet Switch for SAS/SCADA system at 220kV Jath Substation as per the specification: As per schedule. Transportation of material at respective site store will be responsibility of the agency. The Ethernet switch should be compatible with existing SCADA System installed at 220kV Jath Substation. <u>For Further specification and clarification this office is recommended that, the bidder shall visit the Site before submission of bid for confirmation of specification & suitability of equipment.</u>
3	TAXES :	Rates are inclusive of all the taxes.
4	SECURITY DEPOSIT :	Security Deposit 5% of the order value submit to this office in form of a) NEFT/RTGS (b) D.D. from nationalized/scheduled Bank. The security deposit will be refunded only after completion of guarantee period& NOC from respective Unit. If BG is to be submitted Govt stamp duty of 0.1% of SD amount is to be paid.
5	SPECIFICATION :	Work should be carried out as per specification in enclosed Schedule 'A'
6	RISK PURCHASE:	In case of failure to execute the order, the same will be purchased from other agency at our description and difference in cost will be recovered from the tenderer in addition to forfeiture of S.D.
7	QUANTITY & QUALITY :	Quantity & Quality as per schedule A & Specifications.
8	INCOMETAX :	As per govt. rule Income tax at source will be recovered from your bill as per rules. Your Income tax No. may be informed to this office
9	TERMS OF PAYMENT :	The bills should be submitted in triplicate to Concern Unit In-charge. 100% payment will be made on production of following document & completion of ERP activities. A) Invoice B) Guarantee Certificate.
