Sealed & super scribed quotation are invited from date **19.01.2026**, so as to reach this office up to date **25.01.2026 up to 17:30 hrs** for AMC for work of oil filtration of various transformers at various EHV Substations under EHV O&M Division Nanded on following terms & conditions:-

**TERMS AND CONDITIONS:-**

1. The Rate shall be quoted on firm quotation basis.
2. You should quote your rates for all items individually in schedule. No Price variation is applicable. GST rate as applicable will have to be quoted separately in space provided. If nothing is specified rates will be considered as inclusive of all taxes.
3. The quotation should be sent under sealed cover duly super scribed as QUOTATION FOR AMC for work of Oil filtration of various transformers at various EHV Substations under EHV O&M Division Nanded.

4. Your quotation should reach this office **on or before 25.01.2026 up to 17:30 hrs**. Quotations will be opened on the same day, if possible.
5. The rates shall be quoted in **Rupees Only**. The rates and amount shall be written both in Words and figures. The rates quoted shall include all the machineries, T&P and personnel required for executing the works.



6. Income tax, GST & labour cess will be paid /-recovered as per prevailing rules.
7. The rates offer submitted by you should be valid for our acceptance for at least 90days from the last date of receipt of quotation. The accepted rates shall remain the same for entire period work order i.e. price variation will not be applicable to this contract.
8. Payment will be effected by this office by cheque/NEFT/RTGSafter satisfactory completion of work within reasonable time subject to availability of funds.
9. Following documents must be attached with the quotation:-
  - a. Valid electrical contractor's license.
  - b. Valid GST registration
  - c. The experience certificate / work order of executing same type of work officer not below the rank of Executive engineer.
  - d. Valid Bombay Shop Act License.
  - e. PAN Card Copy.
10. The T&P for the work will be arranged by the agency.
11. Order validity:- Work is of AMC nature i.e. the validity of the work order will be one year from the date of issue of final work order / LOA. Agency has to take up the work as and when required at any substation under jurisdiction of EHV(O&M) Division, Nanded.
12. Testing of oil:- The contractor should have calibrated oil testing facility with his filtration plant for testing of oil, its PPM, BDV etc. Off- line filtration of T/F of various capacities should be carried out so as to achieve the desired results as per IS 1866-2000 including testing of oil, topping up complete with DGA, BDV, Tan-delta & PPM results and all allied works. In case of non availability of any of the testing facility due to unavoidable reasons the contractor shall arrange for testing of oil by outside lab at his own cost.
13. The undersigned reserves the right to place order either partly or fully or to reject any or all the quotations without assigning any reasons whatsoever.
14. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
15. The contractor shall be fully responsible for compliance of all statutory and RTO obligations under the Factory Act 1948, Contract Labour (Regulation and Abolition) Act 1970, Maharashtra Labour Contract Regulation & Abolition Act, 1971, Minimum Wages Act, Provident Fund Act and ESIC Act / Workman Compensation Act 1926, Payment of Wages Act in respect of the Staffs deployed. The rules and regulation of the Contract Labour Act shall be binding on the contractor.



16. The Owner will not be responsible for violation of these statutory rules and regulations by the contractor. It shall be the sole responsibility of the contractor to observe all the relevant acts and regulations along with amendments thereto framed by the Government from time to time. The Owner shall not be responsible for violation of any of the above stated regulations / Acts etc. by the contractor.
17. You will have to provide all safety measures to your staffs while executing the work.
18. The payment shall be made only after satisfactory completion of work as certified by the concern Engineer In-charge and as per availability of funds.
- 19. SECURITY DEPOSIT:** The successful Contractor(s) will have to submit Security Deposit at the rate of 5 % of the value of the order, by cash / Demand Draft / Fixed Deposit / Bank Guarantee at the office of the Executive Engineer, EHV O&M Division Nanded, within 07 (Seven) days from the date of receipt of letter of intimation. The Demand Draft / Fixed Deposit / Bank Guarantee submitted towards the Security Deposit shall be in the name of the Executive Engineer, EHV O&M Division, Nanded. If the successful Contractor fails to submit Security Deposit within the stipulated period, it will be presumed that the Contractor is not interested in execution of the contract and the work contract will be issued to other agency (i.e.). The decision of E-enquiry accepting authority i.e. the Executive Engineer, EHV O&M Division, Nanded shall be final and remain binding on the Contractor(s). No interest will be paid on the Security Deposit and the Security Deposit will be refunded after satisfactory execution of works / guarantee period, whichever is later.
- 20. AGREEMENT & STAMP DUTY:-** The successful Contractor has to execute an Agreement with The Executive Engineer, EHV O&M Division, MSETCL; NANDED within 7 days after receipt of the work order. The successful Contractor shall submit an Agreement Bond on non-judicial stamp paper as per the Clause 63 of Mumbai Stamp Duty Act 1958. The expenses towards the stamp paper and preparation of Agreement Bond will be on the part of the contractor.
21. If the work is not carried out within the stipulated time / period, penalty @ ½% per week of the balance works will be recovered from the contractor's bill subject to 10% maximum.
22. Rights of cancellation / modifications of E-Enquiry at any stage, is reserved at this office.
23. The Owner will not be responsible for any fatal or non fatal accident to the personnel of the agency. If any type of misconduct or adverse report against the performance of the personnel of the contractor is reported to this office, the undersigned reserves rights to cancel the contract at any stage. The decision of the undersigned in this regard will be final and binding on the agency.



24. **LIABILITY OF ACCIDENT / LOSS:** The contractor will be responsible for any accident to any of his personnel or loss to him during the work. The responsibility of the insurance towards the same shall be with the contractor. The compensation to the contractor's personnel will be the responsibility of the contractor.
25. **EXCEEDING THE CONTRACT VALUE:** The contractor will have to watch and ensure that the total value of work carried out by him does not exceed the contract value. If the work / value of contract is likely to be exceeded the same should be brought to the notice of the undersigned in writing. If the value of the total work exceeds the order value in that case the contractor is not permitted to execute the work without prior permission from the undersigned.
26. **DAMAGE TO PERSONS AND PROPERTY:** - Contractor will indemnify the MSETCL against any losses and claims regarding any injuries or damage to any person, material or physically damage any property whatsoever which may arise out of or in consequence of the execution of work. During execution of work any damage/loss to Transmission Company's property occurs will be recovered from your bill.
27. **INSURANCE:** (a) The Contractor will have to arrange for insurance at his cost for the men and material associated with the contract till the works are satisfactorily completed. The MSETCL will not be responsible for any accident, or loss, damages, theft, mis-hap. The Contractor will have to lodge, pursue and settle any or all such claims through Insurance Company.  
(b) You will have to full fill the requirement as per Circular No. Ref No. MSETCL/CO/C&M/PT/TKC-II/No-8450 Dt. 30.11.2022 & HO Circular No.4729, Dt,07.07.2023 regarding taking insurance from Directorate of Insurance otherwise it will be deducted from your bill.
28. **TERMINATION OF CONTRACT:** The Undersigned reserve the right to terminate the contract at any stage without assigning any reasons thereof.
29. Validity period of quotation should be 90 days.
30. All the MSETCL's general terms & conditions will be binding on you.
