- 6) Quotations should be duly filled in all respect. Otherwise, it will not be considered. Guarantee period is to be mentioned in the quotation.
- 7) Payment will be paid after satisfactory completion of the work.
- 8) In case of any dispute, decision of the undersigned shall be final and binding on you.
- 9) Rates should be quoted item wise and as per Schedule "A" and for delivery as per consignee mentioned in schedule 'A'.
- 10) Taxes/duties and other levies should be quoted separately.
- 11) GST as applicable will be paid extra.
- 12) Please mention your PAN No; GST No. etc.
- 13) Bill in triplicate should be submitted to this office after satisfactory completion of supply for the payment.
