- 5) The right to reject any or all the quotations is reserved by the undersigned.
- 6) Rates quoted shall be valid for the period of 90 days from date of opening.
- 7) 100% payment will be effected in reasonable time after satisfactory completion of work & submission of bills.
- 8) Material should be provided of reputed make & standard quality only.
- 9) You have to pay 5% of order value as Security deposit.
