

**RESULT OF THE POST OF JUNIOR SECURITY OFFICER/
JUNIOR VIGILANCE OFFICER ADVERTISED VIDE ADVT. NO. 07/2015**

- 1) Advertisements No. 07/2015 was published in the month of December 2015 for filling in the post of Junior Security Officer/ Junior Vigilance Officer. Accordingly, the On-line Test & Personal Interviews were conducted respectively on 11.08.2016 & 03.10.2016.
- 2) The category-wise select & wait list of candidates for the post of Junior Security Officer/Junior Vigilance Officer is drawn.
- 3) **No candidate from ST Category found eligible.**
- 4) While drawing select list, out of 150 marks obtained in On-Line Test have been converted into 95 marks and out of 50 marks obtained in Personal Interview have been converted into 05 marks. Thus, merit list has been drawn out of 100 marks.
- 5) The select list is drawn in order of merit by adding interview marks to the On-Line Test marks of qualified candidates on the basis of aggregate vis-à-vis vacancies advertised.
