

# RESULT OF THE RECRUITMENT PROCESS FOR VARIOUS POSTS ADVERTISED VIDE ADVT. NO. 07/2015 & 01/2016

- 1) Advertisements No. 07/2015 & 01/2016 were published respectively in the month of December 2015 & January 2016 for filling in various posts. Accordingly, the On-line Test & Personal Interview were respectively held on 11.08.2016 & 12.08.2016.
- 2) The category-wise select & wait list of candidates for the post of **Executive** Engineer (Civil), Senior Manager (F&A) & Manager (F&A) is drawn.
- 3) For the post of:
  - i. Executive Engineer (Civil) no candidate from ST Category found eligible
  - ii. Additional Executive Engineer (Civil) no candidate found eligible
  - iii. Assistant General Manager (F&A) no application received
  - iv. Senior Manager (F&A) no application is received from ST Category
  - v. Manager (F&A) candidate from VJ-A category did not appear for on-line test
- 4) While drawing select list, out of 150 marks obtained in On-Line Written Test, have been converted into 95 marks and out of 50 marks obtained in Personal Interview have been converted into 05 marks. Thus merit list has been drawn out of 100 marks.
- 5) The select list is drawn in order of merit by adding interview marks to the On-Line Written Test marks of qualified candidates on the basis of aggregate vis-àvis vacancies advertised.
