2. Terms & Conditions:

- i) The above engineers are appointed as Executive Engineers (Trans.) on **purely temporary** basis until further orders.
- ii) For other terms and conditions, they shall be governed by MSEB Employees' Service Regulations and by such other rules and regulations as are applicable to the employees of the Company.
- iii) Their pay in the post of Executive Engineer (Trans.) shall be fixed in the pay scale of **Rs. 25380-975-30255-1105-54565** as per S.R.29(a) read with S.R.32(b) of the MSEB Employees' Service Regulations from the date of joining as Executive Engineer (Trans) in pursuance of this office order. However, if they have already been granted the higher grade benefit of the post of Executive Engineer (Trans.) under the provisions of G.O.111 (P) dt. 13.05.1982, their pay shall not be re-fixed again in the post of Executive Engineer (Trans.).
- iv) The above engineers will be held eligible for joining time, pay and allowances, T.A. on transfer etc. as per rules provided there is a change in Head Quarter.
- v) Their appointment as Executive Engineer (Trans.) shall be effective from the date of his joining as Executive Engineer (Trans.) in pursuance of this appointment order.
- vi) They should communicate his acceptance or refusal of appointment as the case may be within **a week** from the date of issue of this appointment order failing which it will be presumed that they are not interested in the said appointment and their appointment orders will be cancelled which may please be noted.
- vii) If they are willing to accept appointment on the aforesaid terms and conditions, they should report for duties at the place of posting on before **19.12.2011** positively.
- viii) **No request for modification in posting shall be entertained.**
- xi) The concerned official is requested to relieve the above appointees immediately so as to enable them to join at the place of his posting.
- x) Their relieving / joining report may be sent to this office immediately for necessary record.
