The Maharashtra State Electricity Transmission Company Limited (MAHATRANSCO) is the State Transmission Utility of Maharashtra and one of the largest transmission utilities in India, having workforce of about 16,000 employees, operating around 44988 CKT KM Transmission Lines, 614 EHV Sub-Stations having transformation capacity of 106488 MVA and ambitious plan of network expansion; **invites applications from the cadre of District Judge or Retired District Judge** for the post of *Chief Legal Adviser on Contract* Basis for the period of three years.

Qualification	Degree in Law of recognized University
Experience	Minimum 10 years actual practice in Court of Law preferably in Mumbai or Nagpur or 10 years legal experience including at least 8 years experience of independent handling & management of legal matters in a large Solicitor's firm, proficiency in drafting legal documents including agreements and deeds with experience of similar work in a reputed Industrial Organisation is essential. Preference to candidates with special knowledge of Commercial Law & Labour Law.
Upper age limit	65 years
Method of filling the post	By deputation or by Direct Recruitment on contract basis and shall be from the cadre of District Judge or Retired District Judge.
Period of Contract	The tenure/period of Deputation or Contract shall be for 3 years, counted from the date of joining or till attaining the age of 68 years whichever is earlier.

Note:

- i) A Degree should be from a University or Institute in India, established or incorporated under Central Act or a State Act or any other qualification recognized as equivalent thereto.
- ii) The experience means Post Qualification experience, i.e. experience acquired by the candidate after the essential qualification prescribed for the post.

4. Compensation:-

i. The selected candidate will be drawing salary in the pay scale of ₹ 35875-1545-43600-1710-79510

- ii. In addition to this, he/she would be entitled to Dearness Allowance as applicable on the Basic pay and revised from time to time and other allowances/perquisites applicable to the post.
- iii. The selected candidate would also be entitled for HRA, Medical benefit, CPF, etc. as per Company's Rules.
- iv. The approximate monthly gross emoluments shall be ₹98,000/- (without providing accommodation)

- ii. The call letter for selection process will be forwarded through e-mail on the email ID as mentioned in the application form by the candidate.

- iv. The short listed candidates will have to appear for the selection process at their own cost. Traveling expenses will not be reimbursed.
