## 2. Terms and Conditions

- The pay of above appointees shall be fixed in the pay scale of **Rs.14225-670-17575-705-35905** as per S.R.29 (a) [read with S.R.32 (b)] of MSEB Employees' Service Regulations from the date of joining as Deputy Manager (F&A) in pursuance of this Office Order. However, in respect of such of the appointees who have already been granted the higher grade benefit of the post of Deputy Manager (F&A)/ Manager (F&A) under the provisions of G.O.74(P) dt.30.04.1974, their pay shall not be re-fixed again in the appointed post.
- Their appointment as **Deputy Manager (F&A)** shall be effective from the date of their joining as **Deputy Manager (F&A)** in pursuance of this order.
- The above appointees are held eligible for Tr.TA, Pay advance, Joining time etc., as per Company Rules, if there is change in Head Quarter.
- The above appointees should communicate their acceptance or refusal of appointment as the case may be within 3 days from the date of receipt of this appointment order failing which it will be presumed that they are not interested in the said appointment and their appointment letter will be cancelled which please be noted.
- The refusal of appointment as above will not make the appointees entitled to claim retention at the same place on the grounds of refusal of appointment and liable for transfer in the same capacity.

3. The detailed posting order of appointees (except Sr. No.1, 10 & 14) shall be issued by the concerned Chief Engineer. The detailed posting order in respect of appointees at Sr. No. 1 & 14 shall be decided by the Chief General Manager (F&A).
4. The above appointees should be relieved immediately by making local arrangement but in any case on or before 29.05.2010. Their salary shall not be drawn at present place of working after 29.05.2010.
5. Their relief / joining report should be sent to the concerned establishment groups in Corporate Office, Mumbai accordingly.
