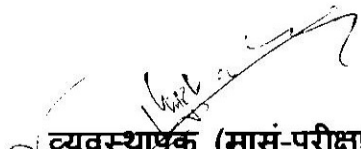

- 3 After display of Roll No list, no further Roll Nos will be allotted at the Examination Centre.
- 4 Candidates appearing for the examination should make their own arrangement of accommodation.
- 5 Candidates are advised to reach the examination centre sufficiently early and occupy the allotted seat 30 minutes before the commencement of the examination.
- 6 Candidates will not be allowed to leave the examination hall during examination period.
- 7 Candidates are not allowed to bring any handwritten or printed material except Companays prescribed books & circulars.
- 8 While writing the answer book if ink gets changed, the signature of the Supervisor must be taken on that page.
