ADITYA VIDYUT APPLIANCES LTD., BHIWANDI, THANE has failed to execute Orders cited under reference for the supply of 50 MVA, 132/33KV Power Transformers (10/16 Nos.), 220/33KV Power Transformers (02/02 Nos.), 167 MVA, 400/220/33KV, 1-\$ ICTs (03/03 Nos.) and 315 MVA, 400/220/33KV ICT (01/01No.) along with New Uninhibited Naphthenic Based High Grade Mineral Insulating Oil placed by C.P.A., C.O. Mumbai. As a result, the aforesaid Orders have been cancelled at the risk and cost of the firm.
