

Final List of the Candidates considered for Selection & Waitlist for the post of Assistant Engineer (Civil) Advertised vide Advertisement No. 04/2022

The On-line Test (Examination) for the post of **Assistant Engineer (Civil)** published as per Advertisement No. 04/2022 has been conducted on **23.11.2022**. After taking into consideration the performance of the candidates reflected in the On-line Test (Examination), number of post advertised, horizontal and social reservation etc., the provisional list of the candidates considered for Selection and Wait list for the post of **Assistant Engineer (Civil)** is published on 10.01.2023 subject to verification of relevant Documents /Certificates and eligibility criteria.

- 2. Accordingly, as per Clause 3 of the said Notification, the candidates provisionally considered for selection were called personally for verification of their Documents/Certificates and eligibility criteria at the Corporate Office, Mumbai by publishing separate notification on Company's website and intimating through e-mail.
- 3. The Candidature of provisionally selected candidates who were absent for Document Verification, failed to submit required Documents/Certificates or the candidates who found Not Eligible for further selection process has been Cancelled.
- 4. As per Clause 6 of the said Notification, taking into consideration the performance reflected in the On-line Test (Examination), the next candidates as per the Merit have been considered for selection.
- 5. Further, Sports Candidates provisionally selected in Select List/Wait List could not submit Sport Certificate in the prescribed format as per the Government Resolution dated 01.07.2016 of Government of Maharashtra. Hence, their provisional candidature has been cancelled and remaining candidates who were applied against Sport Quota were called for documents verification on 28.03.2023.
- 6. Now, on the basis of Documents/ Certificates submitted by the candidates at the time of Documents Verification, the list of the candidates to be considered for Select and Wait List for the post of **Assistant Engineer (Civil)** is revised as under:
