- h) Medical / PWD Certificate (If applied against PWD reservation)
- i) Certificate regarding physical limitation in an examinee to write (if availed Compensatory Time in On-line Test)
- j) Sports Certificate (If applied against Sports reservation)
- k) Orphan Certificate (If applied against Orphan reservation)

- l) Economically Weaker Section Eligibility Certificate (If applied against EWS reservation)
