6. Further, the document verification from original documents of the shortlisted candidates will be done at the time of the Personal Interview. Hence, candidates shortlisted for Personal Interview should bring all original certificates as well as one set of attested Copies of following Certificates:

- m) Socially and Economically Backward Class (SEBC) Certificate (If applied against SEBC reservation) (If applicable)
- n) Marathi Language Certificate (As mentioned in the advertisement)
- o) Change of Name certificate (If applicable)
- p) Experience Certificate
- q) No Objection Certificate from the employer (If working in Government / Semi Government Undertaking)

7. Before appearing for Personal Interview candidates should ensure that they fulfill all eligibility criteria as mentioned in the advertisement. Their admission to all the stages of the recruitment process is purely provisional.

It shall be sole responsibility of the candidate to prove his eligibility with respect to age, qualification, post qualification experience, reservation etc. as required for the post of Additional Executive Engineer (Transmission).
