

PERSONAL INTERVIEW OF SHORTLISTED CANDIDATES FOR THE POST OF "EXECUTIVE ENGINEER (TRANSMISSION) AGAINST ADVERTISEMENT NO. 03/2024"

Ref: - Notification dated 13.03.2025

Vide Notification under reference, the list of candidates shortlisted for Personal Interview for the post of Executive Engineer (Transmission) against Advertisement No. 03/2024 was published.

- 2. The preliminary scrutiny of the shortlisted candidates were done on the basis of information furnished in Application Form. Out of 101 candidates, 42 candidates were found Not Eligible. A list of 42 Not Eligible candidates is enclosed herewith and marked as **Annexure "A".** Therefore, the replacement of candidates sought from Recruitment Agency and again preliminary scrutiny of the replacement candidates were done. Eventually, 82 candidates found provisionally Eligible for Personal Interview. A list enclosed herewith and marked as **Annexure "B"**.
- 3. Now, as mentioned in above Notification, the shortlisted candidates are called for Personal Interview as per schedule mentioned as under -

- 5. Reporting time at the venue for the candidates is 10.00 (AM). All the candidates are requested to remain present at venue well in advance.
- 6. The candidates have to appear for Personal Interview at their own cost. No reimbursement towards travelling or any other expenses shall be paid.
- 7. If the Interview process is not completed on the aforesaid date due to any reason, the same will be continued /held on the next day. Therefore, above candidates are requested to come duly prepared for the same at their own cost.
- 8. Further, the document verification from original documents of the shortlisted candidates will be done at the time of the Personal Interview. Hence, candidates shortlisted for Personal Interview should bring all original certificates as well as one set of attested Copies of following Certificates:
 - a) Application Form
 - b) Degree Certificate and Marksheets of Recognized University or Institute.
 - c) S.S.C. Board Certificate or School leaving certificate for Date of Birth.
 - d) Domicile Certificate (If applied against reservation)

- e) Caste Certificate (If applied against reserve category post)
- f) Caste Validity (If available If applied against reserve category post)
- g) Valid Non-Creamy Layer Certificate. {If applied against reserve category post (Except SC & ST) }
- h) Medical / PWD Certificate (If applied against PWD reservation)
- i) Certificate regarding physical limitation in an examinee to write (if availed Compensatory Time in On-line Test)
- j) Economically Weaker Section Eligibility Certificate (If applied against EWS reservation)
- k) Socially and Economically Backward Class (SEBC) Certificate (If applied against SEBC reservation) (If applicable)
- 1) Marathi Language Certificate (As mentioned in the advertisement)
- m) Change of Name certificate (If applicable)
- n) Experience Certificate
- o) No Objection Certificate from the employer (If working in Government / Semi Government Undertaking)
- 9. Before appearing for Personal Interview candidates should ensure that they fulfill all eligibility criteria as mentioned in the advertisement. Their admission to all the stages of the recruitment process is purely provisional.
- 10. It shall be sole responsibility of the candidate to prove his eligibility with respect to age, qualification, post qualification experience, reservation etc. as required for the post of Executive Engineer (Transmission). In case the applicant failed to do so, his candidature/ appointment will be liable to be cancelled at any stage of recruitment, if appointed, shall be liable for dismissal from the Company's service.
- 11. Any request for change of time, date and/or venue of the Personal Interview will not be entertained under any circumstances.
- 12. Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to their selection/recruitment for the above post shall be considered as DISQUALIFICATION.
- 13. If candidate remains absent for the Personal Interview then it will presumed that he/she is not interested and he/she will be held Ineligible for further selection process.
- 14. Please take note that, calling for Personal Interview does not confer any automatic right of possible employment with the Company.
