

**NOTIFICATION FOR DOCUMENTS VERIFICATION OF SPORTS PERSONS
(QUOTA) CANDIDATES FOR THE POST OF “ASSISTANT ENGINEER
(TELECOMMUNICATION)” ADVERTISED VIDE ADVT. NO. 04/2022**

The Maharashtra State Transmission Company Limited (MSETCL) had published an Advertisement No. 04/2022 on dated 04.05.2022 for filling in 25 post of Assistant Engineer (Telecommunication). Out of which 01 post was earmarked for Sports Person Reservation from Open Category.

2. After taking into consideration the performance of the candidates reflected in the On-line Test (Examination) held on dated **22.11.2022**, the provisional list of the candidates considered for selection for the post of Assistant Engineer (Telecommunication) was published on 10.01.2023. Subsequently, as mentioned in the said notification, the candidates who were provisionally selected were called for documents verification on dated 30.01.2023 and 27.02.2023.

3. After finalizing Eligibility, no Sports Person candidate from provisional Select List & Wait List found Eligible. Prima facie, it was found that these candidates have submitted Sport Certificate which is valid for Pay Group III & IV posts. However, the post of Assistant Engineer (Telecommunication) is a post of Pay Group II in MSETCL. Thus, their Sports Certificate cannot be accepted for Eligibility and they cannot be held Eligible for the post. Considering, this experience and in order to avoid delay in deciding Eligibility and giving appointments to the Eligible Candidates, it has been decided to call 12 candidates in order of merit who have applied under Sports Quota from OPEN category for Document Verification. If more than one candidate found that his Sports Certificate is valid for Sports Quota and found Eligible in all respect, the candidate who is higher in merit amongst them will be considered for appointment. Thus, mere calling for documents verification does not confer any automatic right of possible employment with the Company.

4. Therefore, following Sports Person candidates from Merit List are being called for documents verification on 27.03.2023 **at Prakashganga Building, Plot No. C-19, E-Block, Bandra Kurla Complex, Bandra (East), Mumbai.**

- Domicile Certificate
- Degree Certificate and Marksheets of Recognized University or Institute.
- S.S.C. Board Certificate or School leaving certificate for Date of Birth.
- Sports Certificate
- Marathi Language Certificate (As mentioned in the advertisement)
- Change of Name certificate (If applicable)

6. If candidate remains absent for the documents verification then he/she may be held not interested and he / she will be held not eligible for further selection process.

7. It may please be noted that mere calling for documents verification does not confer any automatic right of possible employment with the Company.
