Sub: - E-Enquiry for hiring of Diesel car or equivalent diesel LMV along with Driver for EHV Line Project Sub-Division, Amravati.

Dear Sir.

Please quote your lowest rates for hiring of Diesel car or equivalent diesel LMV along with Driver for EHV Line Project Sub-Division Amravati, as per M.S.E.T.C.L. rules on the Annexure 'A' annexed herewith and terms and conditions given below. The bidders should submit their sealed and super scribed quotation, so as to reach this office on or before 19.07.2017 up to 13:00 Hrs. and same will be opened on Dt. 19.07.2017 at 15.00 Hrs. onwards, if possible. In case of hand delivery, Quotation should be handed over to receipt clerk of this office. M.S.E.T.C.L. will not be responsible in any manner for the postal delay of any type.

TERMS AND CONDITIONS -

- The LMV is required on per day basis; hence the rate may be quoted on per day basis. Rates quoted 1. should be including of all taxes.
- 2. Minimum average of vehicle without AC should be minimum 15 km/Ltr.
- 3. The Company shall provide only Diesel.
- Normal working hours shall be from 09.00 Hrs to 19.00 Hrs. However, these timings may vary in 4. emergency work.
- 5. The cost of all the maintenance of the vehicle shall be borne by you.
- Vehicle model shall not be more than five years old. Model & its year of Manufacturing shall be 6. mentioned in the bid.
- The vehicle must have valid RTO registration, taxes paid, comprehensive insurance, road permit, "T" 7. permit issued by Competent Authority for engaging the vehicle on hire basis, valid PUC certificate. Xerox copies of all these documents shall be attached along with quotation.
- The vehicle owner shall be responsible for completing the RTO formalities during the course of contract 8. and for maintaining the vehicle on road.
- In case of accident while the vehicle is on duty with the Company, the contractor shall be liable in case 9. of court awarding any compensation amount to the person met with accident and the Company shall not bear any responsibility in such matters.
- The Driver of the vehicle must be sufficiently experienced and must have a valid driving license to drive 10. the said vehicle.
- The hire period will be of One Year w.e.f. effective from date of work order to 31.03.2018. 11.
- The monthly expenditure including fuel and applicable Taxes should not exceed Rs. 40,000/-. 12.

- 13. The rates quoted should be valid for at least one year from the date of placement of order or actual use of vehicle.
- 14. Monthly bill payment will be paid to you by account payee cheque in reasonable time as per the availability of funds after satisfactory completion of work & as per terms and conditions of contract.
- 15. The quotations without the documents as enlisted in Annexure 'A' are likely to be rejected.
- 16. The quotations should be properly sealed and super scribed with the Envelopes "E-Enquiry for hiring of Diesel car or equivalent diesel LMV along with Driver for EHV Line Project Sub-Division Amravati."
- 17. Quotations not complying to the requirements and certificates enlisted in Annexure 'A' may not be considered. Right to accept / reject any or all quotations or part thereof is reserved by the undersigned.
- 18. While submitting the offer, Vehicle documents (Xerox copies) enlisted in Annexure 'A' must be attested.
- 19. The vehicle will be hired for one year 2017-18 only or till exhausted of the order value whichever is later. The period of hiring of vehicle will be normally from the date of actually engaging the vehicle.
- 20. All the expenses regarding vehicle repair/maintenance / driver payment (including OT if any) shall be borne by you. MSETCL shall not bear any responsibility on its account.
- 21. It is mandatory that, the vehicle should be available to the concern engineer in charge in case of emergency. In case of break down or non availability of regular hired vehicle you shall provide alternative suitable vehicle immediately.
- 22. If any accident occurs during the contract period, the complete responsibility of the accident will be to the account of Contractor. MSETCL shall not pay any type of compensation for any type of accident.
- 23. The vehicle is to be driven by the driver to be provided by the agency who must have valid license for driving the vehicle. The driver has to run the vehicle as per the instructions of AdEE, EHV Line Project Sub-Division Amravati. The driver must be polite, punctual in attendance & free from illicit habits throughout the contract period.
- 24. In case of difference opinion, about interpretation of terms & conditions between Owner / Agency & MSETCL, the decision of order placing authority will be final & binding on the Owner / Agency.
- 25. Bidder should not submit 'Conditional Quotation'. Such conditional offer shall be liable for rejection.
- 26. An agreement of appropriate value (not less than Rs.100/-) of stamp paper shall have to be executed with MSETCL before actually hiring of vehicle. The stamp fees will be borne by Agency.
- 27. The agency shall have to pay the prescribe Security Deposit amounting to 5 % of the total value of the contract in the form of cash or D. D. of any nationalized / Schedule bank in the name of Executive Engineer, EHV Projects Division, Amravati payable at Amravati.
- 28. All statutory deduction should be deducted from your bill as per applicable rate.
