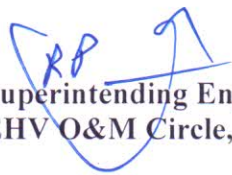
TERMS & CONDITIONS: -

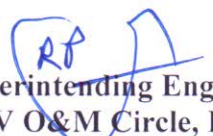
