3. The price quoted by you in your quotation for supply of the material shall be on firm quotation basis for F.O.R. delivery inclusive of packing and forwarding, insurance & transportation.
4. Your quotation should reach this office **on or before 12.09.2017 up to 17:00 Hrs** and the same will be opened on the same day, if possible.
5. Quotation received after due date will not be considered. This office is not responsible for any postal delay.
6. Documents required:- The rate offer must be accompanied with the following documents duly attested & signed by the Agency.
A. Valid Electrical Contractor License or Suppliers License.
B. Valid Proof of registration under GST C. Valid Shop Act licence.
7. The material shall be supplied within 30 days from the date of receipt of this office order otherwise penalty @ 1% per week subject to max.10% of the order amount will be levied at the discretion of the Competent Authority.

8. The rates offer submitted by you should be valid for at least 60 days from the last date of receipt of quotation.
