- 5) The material shall be supplied within 30 days at EHV Projects Circle, Pune from the date of receipt of this office order otherwise penalty @ 1% per week subject to max 10% of the order amount will be levied at the discretion of the Competent Authority.
- 6) Income tax will be recovered as per prevailing rules.
- 7) Payment will be effected by this office by Account Payee cheque after satisfactory supply of material.
- 8) The undersigned reserves right to place order either partly or fully or to reject any or all the quotations without assigning any reasons whatsoever.

- 10) The applicant / Bidder must have valid GST and PAN issued by the Income Tax Department and submit registration certificate.
