ANNEXURE (W)

GENERAL TERMS AND CONDITIONS

1. SUPERVISION OF THE WORKS:

The works shall be under the overall supervision, and shall be subject to the approval of the Executive Engineer concerned, or his designated representative.

2. CONTRACTOR'S EMPLOYEES:

The contractor shall employ and provide onsite only such employees as are skilled and experienced for execution and supervision of works.

3. DAMAGE TO PERSONS AND PROPERTY:

The contractor shall indemnify the Board against any losses and claim in respect of injuries or damage to any persons, material or physical damage to any property whatsoever, which may arise out of or in consequence of the execution of the work.

4. SITE CLEARANCE:

On completion of the works, the contractor shall clear away and remove from the site all surplus materials, rubbish and temporary work of any kind. The site should be kept clean.

- **5.** Any accident to your labours while executing the work / any loss/ damage to the MSETCL's property during execution of work will be on your account & you will have to make it good at your cost.
- **6.** The insurance of your labours will have to be done at your cost. If failed to do so any compensation or claim arrears will be at your responsibility.
- 7. The workmanship & material used should of best quality & confirming to the standard specification

8. SUB-LETTING OF CONTRACT:

The contract or any part there of shall not be assigned, transferred, or sub-let without the prior written permission of the undersigned. Even if such permission is granted, it shall be the responsibility of the principal contractor to whom the work order was originally issued, to execute the works as per the terms of the contract.

9. SECURITY DEPOSIT:

You should pay security deposit equivalent to 5% of the value of the order. S.D. should be paid this office within 7 days from issue of LOI/Work Order. Security Deposit is payable by (a) Cash (b) D.D. (c) Bank Guarantee from a nationalized scheduled Bank. The S.D. will be refunded after satisfactory completion of the work / guarantee period subject to NOC from concern officer.

10. PAYMENT TERMS:

- i) The bills in triplicate, advance stamp receipt, along with the MOM should be submitted to EHV O&M Dn Office Karad. M.B. recording will be done at Dn level.
- ii) 100% payment will be made against receiving of bills, as per availability of funds.

11. TERMINATION OF CONTRACT:

The undersigned reserves the right to cancel the contract, after giving due notice to the contractor, in the even of the breach of contract in any respect.

12. TAX DEDUCTION AT SOURCE:

In accordance with I.T. Act 1961, I.T. will be deducted at source at the prevailing rates from the bills. Similarly any other tax deductible at source, (such as W.C.T.) if applicable to this particular contract, as per statutory provisions (laid down by Central or State Government.) will also be deducted from the bills at the prevailing rates.

13. LIQUIDATED DAMAGES FOR DELAY IN EXECUTION:

Should the contractor fail to complete the works in the stipulated time period, he shall be liable to pay to the Company, the sum equal to one percent of the contract sum (for the delayed portion of work) per delayed day, subject to a maximum of ten percent as liquidated damages, and subject further to Force Major conditions.

Further, if the contractor, after having accepted the contract, is unable to execute the same in full, the Company's reserves the right to get it executed either departmentally or by any other agency, the cost & risk of which shall be borne by the contractor.

14. APPLICABILITY OF GENERAL CONDITIONS OF CONTRACT:

Notwithstanding anything stated here in, the Company's General Conditions of Contract shall be applicable to the contract, as far as they are applicable, in respect of this order.

15. JURISDICATION:

All disputes / differences arising under / out of or in connection with this contract shall be subject to the exclusive jurisdiction of Karad court only.

- **16.** The MSETCL's general terms & conditions of work contract are applicable to this order.
- **17.** The undersigned reserves the right to cancel / modify the order at any time without giving any notice.
- **18.** Please acknowledge the receipt of this order within seven days from the date of receipt, otherwise it will be presumed that all terms & conditions are accepted by you.
