Sealed & super scribed quotations are invited on firm quotation basis for the works indicated in schedule 'A' so as to reach this office on or before 27.11.2017 up to 13.00 hrs. on following Terms & Conditions.

Terms & Conditions:

1) The offer should be submitted in two separate sealed envelopes contained in one main envelope super scribing the subject.

Envelope 1: Should contain associated documents/Certificates/proof of qualifying pre-requisite Broachers attested certificate etc such as,

- 1. Proof of valid electrical contractor license.
- 2. Proof of Valid Bombay Shop act.
- **3.** Proof of GST registration certificate.
- 4. Copy of PAN card.
- **5.** The bidder should have executed at least one work order of 20 % of total estimated cost of this tender (Please Attach)
- **6.** Income Tax return for the last years 2013-14, 2014-15, 2015-16(Please Attach)
- 7. The Bidder should have experience of similar work in MSETCL. The bidder should submit the experience certificate issued by the officer not below the rank of Executive Engineer along with the detail work order. (Please Attach).

If validity of any license/certificate expires during order period, you will have to renew the same & submit the copy to this office.

Envelope 2: Price bid documents: This should contain only price bid in given schedule, not in any other format. After verifying full documents /certificated pre-qualification as above in envelope 1, if it is found that ,bidder fulfills the desired prerequisites, envelope 2. will be opened. If the same is not meeting the prerequisites, Envelope 2 shall not open

- 2) Quotations with incomplete details submitted without sealing or superscripting not submitted in prescribed format etc are liable to reject. Offer on fax or e-mail will not be accepted. This office will not be responsible for delay in postal transit. The agency should not submit 'conditional quotation' such conditional offer shall be liable for rejection.
- 3) The right to place an order for part or to cancel any or all quotations without assigning any reasons is reserved with this office.
- 4) Validity period of offer should be not less than 120 days from the date of submission of offer.
- 5) Signing of Contract: Within 7 days from the date of receipt of the work order, the contractor shall enter into an agreement with the MSETCL of Rs. 500/- before execution of work. Until the agreement is executed, the MSETCL will not allow the contractor to take up the work. Necessary stamp duty for the agreement shall be borne by the contractor.

- 6) Security Deposit: You will have to pay Security Deposit of 5% of the work order value. If you fail to do so, the SD will be recovered from your first bill with interest. Also, you will have to apply for refund of SD within 6 months after complication of guarantee period. If you fail to apply within stipulated period, the action as per CO's rules will taken.
- 7) Scope of work: The scope of work covers following.
- **a**) Overhauling of R-phase pole of SF6 Circuit breaker with complete pole dismantling, re-erection of breaker pole, mechanism, male female contact, compressor with required wiring cable and termination required with replacement of all O-rings gasket contractor if required.
- **b**) Attending SF6 gas leakage from CB pole. Replaning and refilling of SF6 Gas which is extracted from CB pole with dew point test of SF6 gas along with necessary routine test of CB.
- **8) Validity of work order: -** The validity of work order is within three months from the date of issue of work order.

The work is to be carried out on priority after placing of work order during outage period, as per availability of outages.

- 9) The T&P/ labour/ machinery/ equipment/ material required for the work shall be to your account.
- **10) Penalty**: In case of failure to complete the work in stipulated time as mentioned above, you will be liable to pay penalty at rate of 1% per week (a week of 7 days or part there of subject to maximum limit of 10% of the total values of the order.
- 11) Inspection & Supervision:- The works shall be under overall supervision, and shall be subject to the approval of the Executive Engineer, concern or his designated representative. All the material to be used in the contract shall be as per standard specifications of the MSETCL and shall be got approved from the Executive Engineer concerned.
- **12) Quality of Work & Quantities:** You will be responsible for quality of work & workmanship. The material/spare parts used is to be strictly as per the make/requirement on Site. The actual quantities may vary. The payment will be done for the actual quantity of work done.
- **13) Guarantee:** The work done should be of the best & standard quality & as per specification. The work should be guaranteed for minimum **one year**. You should attend the trouble if reported within guarantee period at your risk & cost.
- **14**) The bidder should be fully aware of the M.S.E.T. Co. Ltd. General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.
- **15) Taxes**: All the applicable taxes such as Income Tax will be deducted as per prevailing rate from your bill.
- 16) The right to modify/ alter /cancel the quotation is reserved by undersigned.
- 17) In case of difference of opinion, misinterpretation of any of the condition of the contract. In connection with or arising out of the condition or during the period work, the decision of the under signed shall be final & binding on you.
- **18**) While execution of work, if any loss is caused to M.S.E.T.C.L, the same will be to your account & you will have to make good the loss, work to be attended by you at your cost & risk only.
- **19) Due date of Tender:** All the tenders received up to the due date and time will be opened as far as possible on the specified date and time. In case of urgency of work on the specified date or any connectivity & website related problems, same will be opened on next working day.

- **20**) **Applicability of General Conditions of Contract:** Notwithstanding anything stated herein the M.S.E.T.Co.Ltd.'s General Terms and Conditions of contract shall be applicable to the contract as far as they are applicable to this contract.
- **21) Jurisdiction:** All dispute difference related to the tender contract shall be subject to the exclusive jurisdiction of Pune District Court.
- **22)** If the agency has any doubt the meaning of any portion of the SRM Enquiry conditions/specifications he should get it clarified from the office of the undersigned before submission of the offer.
