- 2. The Vehicle should be in good running condition i.e. tyre, all meter, cushion, viper, etc must be in working & good condition, also the date of manufactured of vehicle within 10 years before date of Enquiry.
- 3. The Vehicle along with Driver should present at duty.
- 4. The Driver has to maintain the vehicle diary daily.
- 5. During the vehicle on road if any problems related to vehicle arises it is owners responsibility.
- 6. Taxes & Charges shall be mentioned clearly. If not mentioned it will be considered inclusive of all taxes & charges.
- 7. Income Tax will be deducted at prevailing rate for every month.
