- 2. Document should upload the following digitally signed scan copies of documents/certificates online under **Technical Bid.**
 - The contractor should have minimum 01 year experience for the same nature of work. The experience of power sector bodies of state government like MAHAGENCO, MSETCL, GEPCO, APTRANSCO etc./ Central government like PGCL, NTPC is essential.

The performance/experience certificate shall be issued by the officer not below the rank of Ex. Engineer. The bidder shall also submit the copy of the work order mentioned in the experience certificate

- P.F. Registration.
- Income Tax return for last Two years.
- Valid Shop Act License.
- Valid Workman Compensation Policy. Valid insurance policy from M/s. United India Insurance Co. Ltd., on co insurance cum servicing basis in the ratio of 40:60 (i.e. the Govt. Insurance fund @40% and the United India Insurance Co. Ltd., @60% which will be valid for 2 years from the date 01.12.2013) entrusted by Director of Insurance, Govt. of Maharashtra. The INSURANCE will be required at the time of execution Before issue the purchase order.
- For execution of work, all T&Ps should be bring by agency personnel.

- Annual Turnover for last year's duly certified by Chartered Accountant should not less than 60% of the estimated cost.
- Net Worth of last year's duly certified by Chartered Accountant should not be less than 20% of estimated cost.
- 3) Rfx fee is Rs.118/- including taxes (Is non refundable)
- 4) If the above documents are not applicable then submit Eligible/ Non eligible documents list.
- 5) Within seven days from the date of receipt of the work order, the contractor shall have to enter into an agreement with the Company for the satisfactory completion of the contract in the approved Performa of agreement of the Company. until such agreement is executed, the Company will not be liable to pay nor shall the contractor be entitled to claim amount due or payable, if any, under the contract. The cost of necessary stamp paper for the agreement shall be borne by the contractor.
- 6) Rates should be inclusive of all taxes & GST should be Mentioned Separately.
- 7) You have to pay amount equal to 5% of the purchase order value within 15 days from the date of issue of letter of intent / purchase order, in the office of the Superintending Engineer, HVDC RS (O&M) Circle, Padghe, Tal. Bhiwandi, Dist. Thane, in cash, or Demand Draft or equivalent Govt. Securities or Fixed Deposit Receipt. The payment of Security Deposit in any other alternative form is not permitted. No interest will be payable by the MSETCL to the Contractor on the Security Deposit. Security Deposit will be refunded after due completion of contractual obligation.
- 8) Contractor will have to make good damages such as thyristor, gate wire, TCU etc., if any, made by him to the M.S.E.T.C.L.'s property during the execution of entire work at his own cost, otherwise the same will be got done by the M.S.E.T.C.L. at contractor's risk and cost.
- 9) Contractor will be responsible for any type of accidents to their workers occurring during the entire course of work and he will have to pay compensation whatsoever as per the prevailing "Workman's Compensation Act"
- 10) Income tax, Insurance, Labour cess & GST as applicable will be recovered from the bill on the total value of the work done as per the prevailing rates for which necessary certificate will be issued from this office.
- 11) Rates should be valid for 90 days.
- 12) Rates should be exclusive of all taxes or all applicable taxes and their charges should be mentioned separately and clearly in percentage.
- 13) Agency should be rate quoted at Estimate cost on Percentage (%) basis.
- 14) Agency should maintain the register for every month.
