- 4) **Name of the Work:** Work order for providing Operators and Technicians at various substations under EHV O&M Dn Baramati.
- 5) **Taxes and Duties:** The rates should be quoted be excluding taxes, levies, incidental charges, Octroi, packing, forwarding, transportation, statutory charges, etc. if any freight, insurance.
- 6) **Rate Validity:** The rates offer submitted by you should be valid at least 180 days from the last date of quotation.
- 7) **Security Deposit:** You will have to pay S.D. at rate 5% of the total amount or order within 7 days from the receipt of firm order, if asked for.
- 8) **Payment:** 100% payment will be made after the work completion by EHV O&M Division Baramati as per availability of funds.
- 9) **Delivery Periods:** You are requested to carry out Work order for providing Operators and Technicians at various substations under EHV O&M Dn Baramati as stated in schedule 'A'
- 10) Along with quotation following documents should be attached:
  - A) Valid Electrical Contractor's License.
  - B) Valid ESI code no. only if applicable. /Labour Insurance/ Workmen Compensation policy
  - C) Valid Registration under GST.
  - D) Valid Shop Act License/ NOC from Local body.

- E) Valid Pan Registration.
- F) Valid EPF Registration.
- G) Valid PT Registration.
- H) Full name of quotation submitting firm, Bank name, bank address, bank account details (Account No., Branch Name, MICR, IFSC) mentioned in separate page.
- I) Income Tax return for the years 2014-15, 2015-16, 2016-17
- J) Attach Solvency Certificate from Nationalized bank/Schedule bank for current year for amount not less than 25% of the work order value
- K) Joint venture not allowed.
- L) The Bidder must have
  - a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost. OR
  - b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost. OR
  - c) One similar completed works costing not less than the amount equal to 80% of the estimated cost. Similar works means providing man power for 220 kV , 132 kV S/Stn only .Work orders with satisfactory work completion certificate signed by the authority not below the rank of Executive Engineer must be attached. Period of work completion must be mentioned on the certificate. OR Equivalent in case of Govt. works OR From authorized authority of private sector, along with copies of works agreement /work orders mentioned in certificate for private sector works.
- 11) All general/technical/commercial terms and conditions of this contract of MSETCL are applicable to this contract.
- 12) **Quantity:** Quantities shown in Schedule “A” are tentative & subject to variation on either side.
- 13) The T&P labour, machinery, equipment /material required for the said supply of material shall be to your account.
- 14) **Penalty:** If you fail to supply the material in stipulated time as mentioned above, you will be liable to pay penalty at rate of 1% per week (a week of 7 days or part there of subject to maximum limit of 10% of the total values of the order.
- 15) **Guarantee:** The material to be supplied should be of the best & of standard quality & as per specification shown in schedule ‘A’. The defective material should be replaced at your risk & cost. The guarantee of material will be 12Months from the date of supply.
- 16) You should be fully aware of the M.S.E. Trans. Co. Ltd. General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.
- 17) **Income tax:** if applicable will be deducted as per rules/ otherwise you will have to submit income tax exemption certificate or income tax registration no. of your firm PAN No.
- 18) The quotation not confirming to the specification is likely to be rejected.
- 19) The right to modify/ alter /cancel the quotation is reserved by the undersigned.
- 20) In case of difference of opinion, misinterpretation of any of the condition of the contract, in connection with or arising out of the condition or during the period work, the decision of the under signed shall be final & binding on you.
