Please send your sealed quotation for the execution of following works under given terms and condition, so as to reach this office on or before. **Dt.22.01.2018 upto 17:30 Hrs.**

Terms and Condition -

- 1 Mode / Destination of Work - **220KV Lonand MIDC S/s.**
- 2 **Completion period** - The work is to be carried out after following safety measures and safety precautions as per Schedule 'A' i.e. 2 times within 6 months from the date of handing over the site for weed control treatment, the period of the order will be **6 months** from the date of handing over of site for work, otherwise the penalty at rate of 1% per day will be deducted from your bill limited to 10% (Maximum). There may be variations in nature and quantity of actual works as per site requirement. The work is to be carried out as per the directives of Addl. Ex.Engineer EHV Projects Line S/Dn., Satara and in presence of his authorized representative. You will have to visit to the site at least once in the month & attended the regular work under supervision of Ex.Engineer EHV Projects Line S/Dn., Satara. The Joint inspection report of work carried out is to be attached to bill.
- 3 **Offer** - Quotation in sealed envelope should be superscribed with the above referred enquiry number & Name of work.
- 4 **Rate** - Rates should be firm & of the foresaid destination.
- 5 **Quantity** - The quantity shown in the above table is tentative & subject to variation on either side.
- 6 **Payment** - Payment will be released within **30** days against final M. B. Recording (SAP formalities). No advance payment will be released.
- 7 **Taxes** - Taxes as per rules on your above rate will be paid extra if applicable. Rates quoted should be exclusive of GST. GST will be paid extra as per prevailing rate if applicable
- 8 **Registration Nos.** -Please furnish your - a) GST Registration No. b) PAN Number c) Shop Act License
- 9 **Experience** certificate towards similar type of work done in the past 3 years.
- 10 **Validity** - Quotation should be kept valid for 60 days from due date. Quotation received late with incomplete details against above clauses will not be considered.
- 11 **Security Deposit:** The Security Deposit of 5% of the order value should be paid within 7 days from the date of intimation.
