AMMENDMENT to the RFX

SRM E-tendering System of MSETCL is now GST Compliant.

All the Bidders have to note that the responses submitted on or before 09.01.2018 have to be compulsorily edited and re-submitted.

The procedure to resubmit the bid is as under:

- 1) Bidder has to click on Withdraw Button in order to enable the Edit Button and edit the response.
- 2) The Pricing Conditions have to be entered again for all the Items. The % GST applicable (Tax Code) as per HSN/SAC has to be selected by the Bidder from General Data Tab under Item Details [Refer the below Table]. Alternatively, these changes can be easily carried out by Download/Upload Template functionality on the Response Page.
