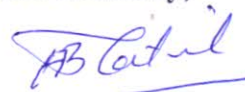
- 1. Scope of work:** - The scope of work is as detailed in Schedule 'A' the work should be carried out as per the instructions of Engineer in-charge.

- All the documents of this enquiry Schedule 'A' and other accompanying documents shall bear the authorized signature of the bidder, failing which the offer will be liable for rejection.
