Please quote your lowest rates for hiring of diesel taxi subject to terms and conditions stipulated below. The quotation may please be submitted in the following format in a sealed envelope super scribed as "Quotation for hiring of vehicle for the Superintending Engineer, EHV Projects Circle, Amravati" so as to reach this office on or before 15/03/2018 up to 17:00 Hrs. In case of hand delivery, the same should be handed over to receipt clerk of this office. Quotations will be opened on the next day @ 11:00 Hrs, if possible.

Terms and conditions:-

- 1) Scope: The vehicle shall be "Maruti Suzuki ClAZ/SWIFT DESIRE /Honda City/Innova (AC) etc, latest model. The vehicle will run throughout Maharashtra State (Particularly in Vidharbha region). The vehicle should be available for 24.00 Hrs. The vehicle registration should be within five years i.e after March-13.
- 2) Rates: Rates shall be quoted on per day basis; along with milage KM/Ltr. The order will be limited to Rs 50,000/- per month or as specified from time to time, whichever is higher, inclusive of fuel.
- 3) **Security Deposit:** The successful bidder will have to pay an amount equivalent to 5% of the contract value towards security deposit in this office.
- 4) **Payment:** 100% payment shall be effected by A/c payee cheque—subject to availability of fund on monthly basis for which you will have to submit the bills in triplicate.
- 5) **Taxes:** Rates should be quoted exclusive of taxes. Taxes if any will be paid extra as applicable.
- 6) Other Charges: All RTO formalities shall be to your account. The cost of lubricant, spares, driver charges, halting charges, over time charges, maintenance charges of

vehicle etc will be on your account. Toll Tax/Border tax/Parking charges will be paid by company extra.

- 7) Only Fuel (i.e. Diesel) will be supplied by MSETCL.
- 8) The quotations without the documents as enlisted as below are likely to be rejected.
- 9) Model of the vehicle should be latest and in any case it should not be more than 5 years old as on March-18.
- 10) During duty period of hiring, all risks, and any accident traffic penalties will be on your account and the insurance liability will be on your part.
- 11) The vehicle should have taxi permit.
- 12) An agreement of appropriate value (not less than Rs.500/-) of stamp paper shall have to be executed with MSETCL before actually hiring of vehicle. The stamp fees will be borne by Agency.
- 13)All the valid documents related with your vehicle must be submitted with quotation duly attested. The list of required document is as below
 - RC & TC books of vehicle offered.
 - · Fitness certificate of the vehicle.
 - Insurance certificate covering all types of risk.
 - Registration certificate/ Route permit of transport contractor.
 - Pollution under control certificate.
 - Income tax return of the last year, PAN Card.
 - Driver having valid driving license.
