

e-Tender Notice

Percentage rate tenders are invited from the registered contractors with MSETCL & who are registered under P.W.D., Irrigation Department, Military Engineering Services, Railway, MHADA, CPWD, BSNL & Maharashtra & Central Government undertaking.

The bidders are required to submit scanned copies of following certificates –

- 1) Valid Certificate Copy of Food & drugs certificate issued by Competent Authority of Government of Maharashtra.
- 2) GSTN Registration Certificate.
- 3) Statement of Net worth for an amount equal to 25% of the estimated cost of work duly certified by Chartered Accountant. Net Worth = Equity share capital + Reserves Revaluation reserves-Intangible assets-Miscellaneous expenditure to the extent not written off and carry forward losses
- 4) Average Financial Turn-over during the last three years ending 31st March of previous financial year should be at least 30% of the estimated cost. The agency has to submit annual Turnover Report/ Profit and Loss Accounts of last 3 years duly certified by Chartered Accountant/ Registered Income Tax Practitioner.
- 5) Agency has to submit the Certificate of Experience for execution of Civil works in Govt. organization as well as private sector duly signed by the officer not below the rank of Executive Engineer or equivalent in case of Govt. works or from authorized authority of private sector, along with copies of agreement of work/work orders mentioned in the certificate for private sector work.

Experience of having successfully completed similar civil works during the last 7 years ending the last day of month previous to one in which the tenders are invited should be either of following.

a. "Three similar completed civil works costing not less than the amount equal to 40% of Estimated Cost.

OR

 b. "Two similar completed civil works costing not less than the amount equal to 50% of Estimated Cost.

OR

- c. "One similar completed civil works costing not less than the amount equal to 80% of Estimated Cost.
- 6) E.P.F. Registration Certificate issued by competent Authority of Govt.
- 7) Partnership deed including Power of Attorney, if Required.

Also, a comfort letter from a Nationalized or Scheduled Bank, address to the employer, which describes the dedicated revolving line of credit, of not less than 25% (twenty five percent) of the estimated cost of the works, that the applicant will be eligible for the same if the bidder is selected for the award of contract.
