3. Estimated amount for the above said work is limited to **Rs. 101541/- (Rs. One Lakh One Thousand Five Hundred Forty One Only including GST & all other applicable taxes.**
4. The Offer shall be valid for acceptance for the period of 120 days from the date of submission.

5. All the documents of this enquiry Schedule 'A' and other accompanying documents shall bear the authorized signature of the agency, failing which the offer shall be liable for rejection.

6. **The envelop should contain following documents:**
