QUALIFYING CONDITIONS

Technical bid (Qualifying Criteria): Tenderer should upload the following digitally scan copies of original documents / certificates online under technical bid.

1. Valid solvency certificate equivalent to an amount not less than **25 %** of the estimated cost of works from scheduled / nationalized bank for the current year.
2. Average annual financial turnover during the **last 3 years** ending 31st March of the previous financial year, should be at least 50% of the estimated cost i.e. **Rs. 1270400/-**. In support of this, the bidder shall submit the annual audited report certified by the statutory auditor in case of company & by Chartered Accountant where accounts are not required to be audited under any law. **Submit Turnover certificate for last 03 years.**
3. Income Tax Returns of last 03 years (2015-16; 2016-17; 2017-18) & Pan Card copy.
4. **Experience certificate** of having done Work of loading & unloading of EHV Class Material during last 3 years (from the scheduled date of submission of tender) having the following:-

Three similar completed works costing not less than the amount equal to **40% of the estimated cost OR Two** similar completed works costing not less than the amount equal to **50 % of the estimated cost OR One** similar completed work costing not less than the amount equal to **80 % of the estimated cost. Lakhs.**

5. Proof of Service Tax Registration for Cargo handling and goods transport.
6. The bidder should have valid Transport Contractor License.
7. The transporter should have own crane. Consent letter from other transporter shall not be submitted. Proof of crane Vehicle registration certificate in the name of transporter, taxation payment receipts, etc. of the vehicles which will be use for work under this contract shall be attached.
8. Proof of registration of firm under Bombay Shop and Establishment Act.
9. Valid insurance against workmen compensation act.
10. Joint venture will not be allowed.
11. GST registration with last three challan copy
12. ESCI and EPFO registration
13. The **Annexure "A"** duly filled in shall be submitted (in Soft Copy) with **qualifying bid.**
