- 4) Rate Validity: The rates offer submitted by you should be valid at least 120 days from the last date of quotation.
- 5) Security Deposit: You will have to pay S.D. at rate 5% of the total amount or order within 7 days from the receipt of firm order, if asked for.
- 6) Payment: 100% payment will be made after the work completion by EHV O&M Division Baramati as per availability of funds.
- 7) Delivery Periods: You are requested to carry out Work of Transportation, Loading & Unloading of various materials under EHV O&M DN Baramati as stated in schedule 'A' within time period as per agreement.
- 8) Along with quotation following documents should be attached:
 - A) Valid Shop Act License/NOC from Local Body.
 - B) Valid GST Registration Certificate.
 - C) PAN Registration.
 - D) The Bidder must have experience of similar work.
- 9) List of similar works executed by the contractor elsewhere preferably with testimony from the concerned shall be attached with this document.
- 10) All general/technical/commercial terms and conditions of this contract of MSETCL are applicable to this contract.
