### **TERMS AND CONDITIONS:-**

#### 1) Scope of work.

The work should be carried out as per enclosed schedule 'A'.

### 2) Value of contract.

Total value of this contract is limited to Rs. 200000/- (Limited up to Rs. Two Lacs only) including GST and other duties and taxes.

### 3) Firm unit rate prices.

The prices of items / unit rates quoted should be firm unit rate and shall not be subject to any price variation on any account.

### 4) Period of completion.

Work should be completed within 08 days from the date of instructions issued by concerned Engineer In-charge for particular job.

- 5) Documents required: The rate offer must be accompanied with following documents duly attested & signed by vendor.
- (i) Registration Certificate of the firm as per Bombay Shop Act with renewal details.
- (ii) GST registration certificate.
- (iii) Copy of PAN card.
- (iv) Order copies/Experience Certificate for similar type of works preferably in MSETCL or Government/Semi-Government/Private organizations. Order copies/Experience Certificate issued by authority not below the rank of Executive Engineer in case of Government/Semi-Government organizations will be required to be submitted.

# 6) Payment:

You have to submit the Bills in triplicate alongwith Weight receipt, Gatepass to concerned Addl.Executive Engineer in-charge office. The concerned Addl.EE after duly recording in MB and SAP Entry (SES) alongwith certificate for having completed the works satisfactorily will submit the bill to this office for effective payment. The payment will be made within a reasonable time at EHV Projects Division office as per availability of funds.

- 7) Security Deposit: The contractor will have to pay an amount equivalent to 5% of contract value towards Security Deposit before commencement of work.
- 8) Agreement: As per provision of 'Mumbai Mudrank Adhiniyam, 1958 clause No.34' an agreement on appropriate value of stamp paper shall have to be executed with MSETCL before commencement of the work. The amount of the fees for such an agreement shall be borne by you.
- 9) Validity of offer: The offer should be valid for our acceptance for a period of 60 days from the Due date of same.

## 10) Income tax deduction at source.

Income tax as per Prevailing rates will be deducted from your bill on the contract value & certificate to that effect will be issued to you.

## 11) Wastage of materials.

Every efforts shall be made to minimize the breakages/losses and wastages of the materials during transportation.

# 12) Jurisdiction of court.

In case of dispute, if any, legal jurisdiction of the Court shall be in Nasik only.

## 13) Manpower and T& P.

MSETCL will not provide T&P and Manpower for above work.

# 14) Accident & loss.

During the execution of work, if any accident is occurred to your staff, the whole responsibility lies on you. Also, if any loss is occurred during the work to the MSETCL's property then the whole cost of equipments will be recovered from your bills or anywhere pending with MSETCL.

15) The insurance of material will be arranged by MSETCL.

- 16) The undersigned has reserved the rights to modify or cancel the order at any stage without assigning any reason thereof and without any liability on MSETCL.
- 17) Besides this, all terms & conditions of MSETCL work contract which are in force will be applicable to this contract also.
