- **4. Name of Work**: Work of Oil Filtration & Oil Top Up for ICT/Power Transformer& OLTC at various EHV Sub Station under EHV O&M Dn Baramati.
- **5. Taxes & Duties**: The rates should be quoted be excluding taxes, levies, incidental charges, Octroi, packing, forwarding, transportation, statutory charges, etc if any fright, insurance.

- **6. Rate Validity**: The rates offer submitted by you should be valid for at least 180 <u>day</u>s from the last date of receipt of quotation.
- **7. Security Deposit**: You will have to pay S.D. at rate 5% of the total amount or order within 7 days from the receipt of firm order, if asked for.
- **8. Payment:** 100% payment will be made after the work completion by EHV O&M DN Baramati as per availability of Funds.
- **9. Delivery periods:** You are requested to carry out Work of Oil Filtration & Oil Top Up for ICT/Power Transformer& OLTC at various EHV Sub Station under EHV O&M Dn Baramati as stated in Schedule 'A' within 90 days from the date of receipt of work order. Three days are reckoned for transit period.
- 10. Along with quotations following documents should be attached,
- A. Valid registration under GST.
- B. Valid Shop Act License.
- C. Valid Govt. Electrical Contractor license.
- D. Valid PAN registration
- E. Bidder must have similar work experience executed from the authority not below the rank of Executive Engineer.
- **11.** List of similar works executed by the contractor elsewhere preferably with testimony from the concerned shall be attached with the documents.
- **12.** All general /technical /commercial terms & conditions of the contract of MSETCL are applicable to this contract.
- 13. Quantity: Quantities shown in Schedule "A" are tentative & subject to variation on either side.
- **14.** The T&P labor, machinery, equipment /material required for the said supply of material shall be to your account.
- **15. Penalty:** If you fail to supply the material in stipulated time as mentioned above, you will be liable to pay penalty at rate of ½ % per week (a week of 7 days or part there of subject to maximum limit of 10% of the total values of the order.
- **16.** You should be fully aware of the M.S.E. Trans. Co. Ltd. General Condition for execution of work and same is applicable to this contract also. Any of the condition will not exempt you from your liability to be abiding by the same.
- **17. Income tax**: if applicable will be deducted as per rules/ otherwise you will have to submit income tax exemption certificate or income tax registration no. of your firm PAN No.
- **18.** The quotation not confirming to the specification is likely to be rejected.
- **19.** The right to modify/ alter /cancel the quotation is reserved by the undersigned.
- **20.** In case of difference of opinion, misinterpretation of any of the condition of the contract, in connection with or arising out of the condition or during the period work, the decision of the under signed shall be final & binding on you.
