



4. **PAYMENT:** - On completion of the order successfully, the bill in triplicate should be submitted to concern office. After GI in ERP and Bill certification, the payment will be made within a reasonable time by Concern Office.
5. **SECURITY DEPOSIT:** - The successful bidder will have to pay an amount equivalent to 10 % of contract value towards S.D. at concern office.
6. **VALIDITY OF OFFER:** - The offer should be valid for our acceptance for a period of 60 days from the Due date of same.
7. **Consignee:** The ordered materials should be delivered to EHV PC O&M Zone Office, Karad
8. In case the work is not done within specified period, the agency shall be **liable** to pay penalty @ 1 % per delayed day, maximum upto 10% of the order value will be recovered from your bill
