TERMS AND CONDITIONS

- 1. Due Date:** - The Quotation complete in all respect, duly sealed & super scribed should be submitted to this office on or before **Dt.20.08.2018** up to **15:00 Hrs** Positively.
- 2. Scope of work:** - As detailed in schedule "A".
- 3. Quoted Rates:** - The quoted rates should include the cost of labour and also the requisite T & P, incidental charges, Fuel charges etc. The Taxes & charges shall be mentioned clearly. If not mentioned it will be considered inclusive of all taxes & charges.
- 4. Period of Contract:** - You will have to carry out the said work for 1 Year from the receipt of the work order or intimation to you by Executive Engineer or his representative.

5. **Payment:** - Quarterly RA Bill payment will be paid to you by account payee Cheque in reasonable time and as per the availability of funds after the satisfactory completion of work and as per Bill certified by Addl. EE (Maint.) 400 kV R.S. Khadka-Bhusawal.
6. Please quote your PAN, No and GST No. on your quotation /Bill, otherwise, Taxes as per rules will be deducted from your bill.
7. **Security Deposit:** - The successful contractor shall have to deposit the security deposit of @5% of contract value towards security deposit in this office by cash/DD/B.G./FDR before commencement of the work. The same shall be refunded to you after satisfactory completion of G.P. and as per availability of funds.
8. **Agreement:** - An Agreement is required to be executed by the person with the companies on stamp paper of Rs.500/- containing all the terms and conditions of the order before its execution.
9. **Validity of Offer:** - The offer should be valid for our acceptance for a period of 120 days from the due date of same.
10. **Document required:** - The offer rate must be accompanied with following documents duly Signed by vendor/contractor.
 - i. Firm Registration Copy/Shop establishment Copy/NOC from Grampanchayat.
 - ii. Valid GST registration certificate if applicable otherwise Submit the Undertaking.
 - iii. PAN Card Xerox.
 - iv. Work order copies/Experience certificate issued by authority not below the Rank of Executive Engineer or equivalent of similar type of works as a proof of experience of any type of Government/Semi- Government/Private organization.
11. According to the financial Act 194 (C) OF 1972 income tax will be deducted from your Bill as per rules and certificate to that effect will be issued to you.
12. **PENALTY FOR DELAY:** The work should be completed within time period and completed as per directives of operating officer/Engineer in charge, failing to which the penalty will be charged at the rate of @ 0.50% (half - percent) per week (On delayed portion) or part thereof. The total amount of penalty charged will be subject to maximum of 10% of the ordered value.
13. Undersigned reserved the right to accept any quotation or to reject/ accept all the quotation without assigning any reason.
14. For any dispute/differences arised, that will be subjected to jurisdiction of Bhusawal court only.
15. The work shall be supervised by the Addl. Ex. En. 400 KV (Maint.) S/Dn, Khadka- Bhusawal & carried out satisfactorily. In case of any dispute, decision of undersigned shall be final and binding on the contractor.
16. MSETCL Reserve rights to add more terms during the contract period if found necessary.
17. The order value/ contract period will be valid for 1 year or till the exhaust of Order Value.
18. The crane driver provided by the contractor should have the driving license for drive the such type of Crane and shall be free from any bad habits like smoking, drinking etc. and should be well convergent.
19. The Normal working time for the crane on the required day on per hour basis. However in case of emergencies, the crane have to spared by the contractor before or after the stipulated time as per the instructions of Executive Engineer, 400kV RS Dn, Khadka-Bhusawal.
20. The contractor will be intimated 12 hrs. in advance whenever the crane is required. However in case of emergencies, no prior notice can be given, and the contractor have to arrange the crane immediately whenever told by the Executive Engineer, 400kV RS Dn, Khadka-Bhusawal.
21. The crane provided by the contractor should be provided with all necessary crane belts, its binding material etc.
22. The crane fuel (diesel/petrol) and lubricants to be borne by the crane provider. This office will not provide the same in any case.
23. If in case, the crane fails or stops working in the middle of the work, the contractor has to immediately provide another crane suitable for the work.
24. The necessary maintenance to be carried out and the cost of the same to be borne by the contractor only.

25. **Liquidated Damages / Loss due to theft:** - Any damage or loss to M. S. E T. Co. Ltd's property due to your employees' negligence during the course of contract shall be on contractor's part and same shall be recovered from the bill.
26. The M. S. E. T. Co. Ltd. shall not be responsible for injury or death of your employee during the course of contract. Contractor will have to provide safety equipments to his employees.
27. Contractor will be solely responsible for compensation or medical treatment etc. for all the liabilities arising out of such accident. It shall be the sole responsibility of the contractor to observe all the relevant acts and regulations along with amendments thereto framed by the Government from time to time. The MSETCL shall not be responsible for violation of any of the above stated regulations / Acts etc. by the contractor.
28. The disputes, if any, shall be subjected to the jurisdiction of the Bhusawal Court only.
29. The undersigned reserves the right to cancel the E-enquiry at any stage or cancel any or all quotations without assigning any reason thereof.
30. Agency should have to pay to **Rs. 100/-** against enquiry Quotation Fees by cash to this office & copy of receipt attached with quotation.
